<u>Block 17 Lot 3 TWA Submittal Authorization</u> – The following resolution was presented for consideration:

BOH RESOLUTION #08-2015

WHEREAS, soil testing was performed on Block 17 Lot 3, 14 Stymiest Road in April of 2011 for a proposed five bedroom dwelling; and

WHEREAS, the regional high water table was found at 17 inches which is less than the maximum allowed by code of 24 inches from existing grade; and

WHEREAS, the proposed design will be not be in full conformance with 7:9A and is new construction. Therefore the application will need to go to the DEP for review and issuance of a Treatment Works Approval Permit; and,

WHEREAS, the Hunterdon County Division of Public Health Services, in their letter of July 1, 2015 requested that the Board either act or acknowledge the following as a condition of making application to the DEP

The regional water table is at 17 inches and since this is new construction, a TWA permit will need to be obtain from the DEP.

WHEREAS, it was the consensus of the Board members that the Division of Public Health Services be authorized to sign and submit the TWA application, with formal action of same to be taken that the Board's August 27, 2015 meeting.

THEREFORE BE IT RESOLVED, by the West Amwell Township Board of Health, that the signing and submission of the TWA application for Block 17 Lot 3 by the Hunterdon County Division of Public Health Services to the DEP is hereby formally approved.

The Resolution was unanimously approved on motion by Rich, seconded by Cally.

UNFINISHED BUSINESS

<u>Update on Salt Testing</u> – Results of the July 22, 2015 testing were presented, together with an e-mail from Chair Kropp providing a brief explanation of the numbers. Concern was noted on one particular well as the results have steadily increased over time. All other wells have shown fluctuations over the same time period. The latter are most likely due to both weather and well/water use patterns. The well on the former Perrine property is getting more use per the secretary's conversation with the current owner.
