## **REORGANIZATION**

## SWEARING IN:

A new law specifically requires anyone newly appointed to a municipal entity to take an oath of office for that specific position, in addition to the general oath of office. Attorney Faherty administered same to Thomas J. Molnar, Frank P. Masterson, III, George A Fisher for one year terms, Kenneth T. Hart for a 3 year term, Wendy Williams for an unexpired two year term as Alternate #1 and James Cally for a two year term as Alternate #2

Williams will participate as a full voting member this evening.

WHEREAS, the West Amwell Board of Health is need of soil witness(es) for its Soil Testing program for 2010, and

<u>Vet for Rabies Clinic and Emergencies</u> - Dr. Maxian will do the Rabies clinic in May. His cost is \$100/hour. The proposal was unanimously accepted.

<u>Animal Control Holding Facility Contract for 2010</u> – Dr. Tindall of the Mobile Veterinary Service will again provide the Township with this service. Dr. Tindall was paid a grand total of \$30.00 in 2009.

The Chair was unanimously authorized to sign the contract on motion from Molnar, seconded by Williams.

<u>Model Ordinance – Lead Poisoning Prevention</u> – This proposal was received from the Department of the Public Advocate in response to Governor Corzine's

Executive Order #100 that challenged State agencies that deal with lead to enhance their efforts and to work more collaboratively. Mr. Cally provided an overview of the provisions which lead to a brief discussion by Board members who questioned administrative issues and if this was any huge concern in West Amwell. Board members will review for the next meeting.

<u>Invitation to 2<sup>nd</sup> Annual Local BOH Orientation Session</u> – Members Williams and Fisher will definitely attend. Cally and Molnar expressed interest but could not immediately confirm.

### **CLOSED SESSION & RESULTS, IF ANY:**

### **CORRESPONDENCE:**

The following items were received from the Hunterdon County Health Dept.:

- A letter concerning the pending subdivision of Block 21 Lot 12 was received.

- The 2<sup>nd</sup> Annual Local BOH Orientation Session will be held February 23<sup>rd</sup> at the County Complex.

- NJ LINCS provided information on Influenza-Like-Illness. Hunterdon County has had 27 confirmed cases by culture of the virus.

- A synopsis of NJ Animal Rabies Cases by County for 2009 showed Hunterdon with 7 terrestrial cases and 1 bat. The counties with the highest number of diagnosed animal rabies cases were Burlington (30), Morris (23), Ocean (25), and Passiac (24).

### DISCUSSION:

Jim Cally presented a recent article about Franklin Township's regulation of septic systems, noting that something similar may be coming our way. It was mentioned that the approved Wastewater Management Plan supposedly exempts the Township from this proposed DEP requirement. However, a failing system impacts both adjacent homeowners and the aquifer thereby becoming a

health issue for everyone. A brief discussion ensued about the need for homeowner education on the use and care of their septic system.

A second article concerning New Jersey's clean water, and carrying a similar theme, mentioned that legislation is being considered that would extend the deadline for counties to comply with new wastewater regulations and take ultimate authority for approving new wastewater plans from DEP and give it to the State Planning Commission, a 'dysfunctional body with no expertise or authority over this critical area,' according to the article.

The Board members were advised of the need to submit their Financial Disclosure/Ethics forms. A copy of the form and a memorandum giving the web address for on-line preparation was provided in the meeting packet.

### **ADJOURNMENT:**

There being no further business before the Board, the meeting was unanimously adjourned at 8:35 p.m. on motion from Molnar, seconded by Masterson.
