WEST AMWELL TOWNSHIP BOARD OF HEALTH RE-ORGANIZATION & REGULAR MEETING January 18, 2023 – 7:00 PM

The West Amwell Township Board of Health met on the above date.

The meeting was called to order at 7:00 PM by Ken Hart. The meeting was declared in compliance with the Open Public Meetings Act as it was advertised as a reorganization meeting to be followed by a regular meeting in the December 15, 2022 issue of the Hunterdon County Democrat. Notice of the meeting has been continuously posted on the Township bulletin board. A copy of this notice is and has been available to the public and is on file in the office of the Municipal Clerk.

APPOINTMENTS/OATHS OF OFFICE

Board Secretary/Township Clerk Maria Andrews administered the Oaths of Office to James Cally, Meghan Hudson and John Cronce.

Mr. Hoyer commented that Ms. Hudson had reached out to him regarding the committee appointments that were made at the Township Committee Re-organization meeting. He asked Mr. Cronce to address the potential conflict raised by Ms. Hudson regarding his serving on the Board of Health and owning J. Cronce Septic & Excavating, LLC.

Mr. Cronce confirmed that while he has sold off some equipment, he still owns his business. He commented that he has served the Township for many years starting with his appointment to the Planning Board in 1984 and was later elected to Township Committee, served as Mayor and most recently sat on the Board of Adjustment. Mr. Cronce remarked that he doesn't believe there is any conflict and stated that no one has ever questioned him serving any of the Boards or Committees over the years.

Ms. Hudson recognized Mr. Cronce's service to the Township and expressed he is a pillar of the community. She noted her concern is the perception of his owning a septic business and the Board reviewing septic applications. She remarked that she is viewing things from a risk mitigation standpoint and suggested that perhaps Attorney Pandos could draft something that would protect the Board and Township from any potential lawsuit while having Mr. Cronce on the Board of Health.

Mr. Cronce stated he has not had any conflicts for over 30 years of service.

Mr. Bergenfeld remarked that all contracting, engineering and excavating is done after any approvals from the Board of Health.

Mr. Cally commented that the New Jersey Department of Environmental Protection (NJDEP) and/or the County Board of Health review all of the applications and he stated he has no issue with Mr. Cronce serving on the Township Board of Health.

Mr. Dale asked if Mr. Cronce still installs septic system. Mr. Cronce responded that he is 65 years old and doesn't have the staff to design or install septic systems.

Attorney Bykov did not provide any legal opinion on the matter and there was no further discussion among the Board Members.

NOMINATION OF CHAIR

Secretary Andrews called for nominations for the Board's Chair. A motion by Hoyer, seconded by Bergenfeld nominating Mr. Hart as the Board's Chairman was unanimously approved by voice vote.

The Board congratulated Mr. Hart and he took over the meeting at this time.

Chairman Hart called for nominations for the Board's Vice Chair. A motion by Dale, seconded by Hoyer nominating Mr. Cally as the Board's Vice Chairman was unanimously approved by voice vote.

PRESENTATION OF MINUTES

A motion by Bergenfeld, seconded by Cally to approve the Board's 11/16/22 meeting minutes with no revisions noted, was approved by voice vote with Ms. Hudson and Mr. Cronce abstaining.

AGENDA REVIEW

Secretary Andrews noted for the record that there were no changes to the posted agenda.

OPEN TO THE PUBLIC/TOPIC NOT ON THE AGENDA

Chairman Hart opened the floor to public comment.

Harry Heller of 27 Old York Road came forward and asked who gets the "As-built" plans for septic systems. He noted he is inquiring because he is still trying to resolve the issue of his neighbor's septic system being built on his property a few years ago. Engineer Doug Fine spoke up from the public and explained the County files all of the as-built plans. It was suggested that Mr. Heller follow up with the County.

Joel Coyne of 3 Old River Road commented that when he worked for the Health Department as-builts were not required.

Linda Meier of 228 Rock Road West asked if the public will be allowed to comment on any of the resolutions. Chairman Hart stated that as each one comes up there will be an opportunity for public comment.

INTRODUCTION OF ORDINANCES AND/OR PUBLIC HEARING AND/OR SPECIAL PRESENTATON

It was noted for the record that there were no Ordinances listed on the agenda for action.

NEW BUSINESS

<u>Septic Waiver: Alteration – Block 15 Lot 3: 22 Rocktown Hill Road</u>

Present for the discussion was Engineer Doug Fine of Fine Engineering.

Engineer Fine explained the septic alteration is to correct a malfunctioning system to an existing 3 bedroom dwelling. He noted the proposed system will incorporate a Hoot H-500A advanced treatment unit (ATU). Engineer Fine requested the Board consider the following waiver from the code:

1. The proposed disposal system will be only 79 ft. from the existing well which does not meet the required 100 ft. setback requirement. Per the Code, the distance can be reduced to 50 ft. provided there is 50 ft. of casing in the well.

Engineer Fine commented that due to the age of the well, he will install an ultra violet treatment device for added protection and conduct a water test for coliform after the system has been installed.

It was noted for the record that proof of the maintenance contract must be provided to the West Amwell Township Board of Health and to the Hunterdon County Division of Health. It was also noted that the deed restriction be recorded and a copy of the maintenance agreement be provided by the owner and kept with the house as maintenance will be required by a service provided for the life of the ATU system.

A motion by Dale, seconded by Hudson to approve the requested waiver was unanimously approved by voice vote.

Septic Waiver: Alteration – Block 8 Lot 52.02: 1410 Route 179

Present for the discussion was Engineer Casey Wood of Bayer-Risse Engineering.

Engineer Wood explained the septic alteration is to correct a malfunctioning system to an existing 4 unit apartment building with a total of 1400 gpd and proposed installation of an ATU. The design will incorporate a pre-treatment tank and a Hoot H 960-1500 model. Engineer Wood requested the following waiver from the code:

1. The proposed disposal system will only be 38 ft. from the existing water course on the property, which does not meet the required 50 ft. setback under the code.

Engineer Wood noted the building has three 1-bedroom units and one 2-bedroom unit.

There was some discussion on the 50 ft. drainage easement. Engineer Wood explained they believe it is really a ditch but the County is calling it a stream. She noted that they cannot meet the required 50 ft. setback but will maintain the existing 38 ft. distance. Engineer Wood remarked this will be a mounded system and they will maintain the existing drainage conditions on the property. She clarified they are not required to go to NJDEP because this is an alteration, not a new system and they are staying out of the conservation easement.

Mr. Cronce asked about the 24" pipe and whether or not it should be relocated. Engineer Wood commented that they could relocate it to the other end of the septic bed. The Board believed the suggested relocation was a good idea.

It was noted for the record that proof of the maintenance contract must be provided to the West Amwell Township Board of Health and to the Hunterdon County Division of Health. It was also noted that the deed restriction be recorded and a copy of the maintenance agreement be provided by the owner and kept with the house as maintenance will be required by a service provided for the life of the ATU system.

Additionally, the auto dialer device must be recorded and installed by an installer who has a NEHA certification. A copy of this certification must be provided to the Township Board of Health and forwarded to the County Division of Health.

A motion by Hudson, seconded by Hoyer to approve the requested waiver with the condition that the 24" pipe be relocated was unanimously approved by voice vote.

<u>Discussion: TWA Authorization – Septic Waiver: Alteration – Block 8 Lot 12: 1490 Route 179 – Approval of Resolution #06-2023</u>

Present for the discussion was Engineer Wayne Ingram of Environmental & Land Planning Associates, Inc. He explained the design is for the permanent use of a 3000 gallon heavy duty holding tank with a high level alarm. The tank will support the proposed 5 bay service station as well as 750 sq. ft. of office

space allowing for a total of 343.75 gpd. Engineer Ingram noted a holding tank is the only option because the property was subdivided and the neighboring wells are too close.

Engineer Ingram stated the tank will be underground with an alarm and aerator. He indicated they will provide two signed contracts with licensed sewage haulers for pumping the holding tank which is a requirement for the TWA application they have to submit to the NJDEP.

Ms. Hudson asked if there are any reports or soil test results for the property. Engineer Ingram said no, because there is no place of the site for a septic system to be installed. She asked when the original system was built. Engineer Ingram stated, "60 years ago."

Township of West Amwell Board of Health Resolution #06-2023 Authorizing the County Board of Health to Sign the Treatment Works Approval (TWA) Permit from NJDEP for Block 8 Lot 12 – 1490 Route 179

WHEREAS, Block 8 Lot 12 located at 1490 Route 179 is an existing automotive repair shop; and

WHEREAS, Wayne Ingram, P.E., P.L.S., P.P., C.M.E. of Environmental & Land Planning Associates, Inc. (E&LP) submitted plans to the Hunterdon County Department of Health for a septic system alteration designed to permanently incorporate the use of a holding tank; and

WHEREAS, the holding tank was designed for a 5 bay service station and 750 sq. ft. of office space with a total of 343.75 gallons per day; and

WHEREAS, it has been determined that two signed contracts with licensed sewage haulers for pumping the holding tank is a requirement for a Treatment Works Approval (TWA) permit from the New Jersey Department of Environmental Protection (NJDEP); and

WHEREAS, as indicated on the TWA application, it is the Board's responsibility to acknowledge the application and can subsequently authorize the County to be the Authorized Agent and sign the TWA to be submitted to NJDEP; and

NOW THEREFORE BE IT RESOLVED that the Local Governing Body of the Township of West Amwell will provide consent solely on form WQM-003 for the Treatment Works Approval permit affirming the project is in conformance with municipal laws and reaffirms the County Board of Health is the Administrative Agent with the authority to review and sign the TWA application for Amwell Automotive, Inc.

Discussion: TWA Authorization: Block 16 Lot 17.02 – Approval of Resolution #05-2023

Present for the discussion was Engineer Wayne Ingram of Environmental & Land Planning Associates, Inc. He explained that the property owner is requesting that NJDEP evaluate and confirm the flow calculations they have provided and in order to do so, the Township must verify it doesn't violate municipal laws and reaffirms the County Board of Health's authority to review and endorse the application to NJDEP.

Ms. Hudson asked for clarification on the different forms, noting the WQM-003 is the "statement of consent" which was missing, but was the correct form to be signed. Engineer Ingram explained the County Board of Health signs the WQM-006 form because they are only seeking a flow determination. He remarked that the form doesn't really make sense but stated that is the only form NJDEP has for this type of request.

Chairman Hart opened the floor to the public on this matter.

Linda Meier of 228 Rock Road West came forward and asked numerous questions regarding what authority the Board had to direct the County to sign off on the application to NJDEP. Attorney Bykov commented that if the County is already the authorized agent for the Township, it does no harm to essentially reinforce that premise.

Ms. Hudson suggested several amendments to the resolution which were supported by the other Board members and agreed to by Engineer Ingram.

WHEREAS, Wayne Ingram, P.E., P.L.S., P.P., C.M.E. of Environmental & Land Planning Associates, Inc. (E&LP) has been hired to determine the projected volume and flow of wastewater for the proposed project; and

WHEREAS, it has been determined that a Treatment Works Approval (TWA) permit from the New Jersey Department of Environmental Protection (NJDEP) is being sought for the sole purpose of determining and confirming that the flow calculations provided by E&LP are accurate; and

WHEREAS, as indicated on the TWA application, it is the Board's responsibility to acknowledge the application and can subsequently authorize the County to be the Authorized Agent and sign the TWA to be submitted to NJDEP; and

NOW THEREFORE BE IT RESOLVED that the Local Governing Body of the Township of West Amwell will provide consent solely on form WQM-003 for the Treatment Works Approval permit affirming the project is in conformance with municipal laws and reaffirms the County Board of Health is the Administrative Agent with the authority to review and sign the TWA application WQM006 for Green Medicine.
