**BOND ORDINANCE AMENDING AND SUPPLEMENTING BOND ORDINANCE NUMBER 05, 2022
FINALLY ADOPTED BY THE TOWNSHIP COMMITTEE ON MAY 18, 2022, TO INCREASE THE
APPROPRIATION THEREIN BY \$100,000 AND TO INCREASE THE AUTHORIZATION OF BONDS
OR NOTES THEREIN BY \$95,238 TO FINANCE PART OF THE ADDITIONAL COSTS THEREOF**

BE IT ORDAINED AND ENACTED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WEST AMWELL, IN THE COUNTY OF HUNTERDON, STATE OF NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

SECTION 1. The bond ordinance of the Township of West Amwell, in the County of Hunterdon, State of New Jersey (the “City”), heretofore finally adopted by the Township Committee on May 18, 2022, Number 05, 2022, entitled: “BOND ORDINANCE PROVIDING FOR VARIOUS 2022 CAPITAL IMPROVEMENTS, BY AND IN THE TOWNSHIP OF WEST AMWELL, IN THE COUNTY OF HUNTERDON, STATE OF NEW JERSEY (THE “TOWNSHIP”); APPROPRIATING \$910,268.75 THEREFOR (INCLUDING VARIOUS GRANTS IN THE AGGREGATE AMOUNT OF \$358,268.75) AND AUTHORIZING THE ISSUANCE OF \$524,400 BONDS OR NOTES OF THE TOWNSHIP TO FINANCE PART OF THE COSTS THEREOF” (the “Original Ordinance”), is hereby amended and supplemented to the extent and with the effect as follows:

SECTION 2. For the improvements or purposes described in Section 3(a)(i) (as to the Rocktown-Lambertville Road and Quarry Street improvements) of the Original Ordinance, as amended and supplemented hereby, there is hereby appropriated the additional sum of \$100,000, said sum being inclusive of \$4,762 as the amount of an additional down payment as required by the Local Bond Law, N.J.S.A. 40A:2-1 et seq., as amended and supplemented (the “Local Bond Law”), now available therefor by virtue of a provision or provisions in a previously adopted budget or budgets of the Township for down payment or for capital improvement purposes. Therefore, the total appropriation contained in the Original Ordinance, as amended and supplemented hereby, shall be increased by \$100,000 from

\$910,268.75 and shall equal the amount of \$1,010,268.75, said sum being inclusive of all appropriations heretofore made in the Original Ordinance, as amended and supplemented hereby, including the total amount of down payment increased by \$4,762 from \$27,600 to equal \$32,362. The total appropriation including the total amount of down payment is \$1,010,268.75.

SECTION 3. In order to finance the additional cost of the improvements or purposes set forth in Section 3(a)(i) (as to the Rocktown-Lambertville Road and Quarry Street improvements) of the Original Ordinance, as amended and supplemented hereby, not covered by the additional down payment, additional negotiable bonds or notes of the Township in the amount of \$95,238 are hereby authorized to be issued by the Township for such improvements or purposes in Section 3(a)(i) (as to the Rocktown-Lambertville Road and Quarry Street improvements) of the Original Ordinance, as amended and supplemented, such that the total authorization of negotiable bonds or notes to be issued by the Township for the improvements or purposes set forth in the Original Ordinance, as amended and supplemented hereby, shall be increased by \$95,238 from \$524,400 and shall equal the amount of \$619,638.

SECTION 4. Section 3(a)(i) of the Original Ordinance shall be amended to read in its entirety, as follows:

SECTION 5. Section 7(b) of the Original Ordinance shall be amended to read in its entirety, as follows:

“The average period of usefulness of said purposes within the limitation of the Local Bond Law, according to the reasonable life thereof computed form the date of the said bonds authorized by this bond ordinance, is 10.97 years.”

SECTION 6. Section 7(d) of the Original Ordinance shall be amended to read in its entirety, as follows:

“An aggregate amount not exceeding \$203,000 for items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included in the estimated cost indicated herein for the purposes or improvements herein before described.”

SECTION 7. The Capital Budget of the Township is hereby amended, as necessary, to conform with the provisions of this amendatory and supplemental bond ordinance and to the extent of any inconsistency herewith, a resolution in the form promulgated by the Local Finance Board showing full detail of the amended Capital Budget and Capital Program as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs (the “Director of the Division of Local Government Services”), will be on file in the office of the Clerk and will be available for public inspection.

SECTION 8. The Supplemental Debt Statement required by the Local Bond Law has been duly made and filed in the Office of the Clerk of the Township and a complete executed duplicate thereof has been filed in the Office of the Director of the Division of Local Government Services, New Jersey Department of Community Affairs, and such statement shows that the gross debt of the

Township as defined in the Local Bond Law is increased by the additional authorization of the bonds and notes provided for in this amendatory and supplemental bond ordinance by \$95,238 and the said obligations authorized herein will be within all debt limitations prescribed by law.

SECTION 9. The full faith and credit of the Township are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by the Original Ordinance, as amended and supplemented hereby. The obligations shall be direct, unlimited obligations of the Township, and the Township shall be obligated to levy *ad valorem* taxes upon all the taxable property within the Township for the payment of the obligations and the interest thereon without limitation as to rate or amount.

SECTION 10. The Township hereby declares the intent of the Township to issue the bonds or bond anticipation notes in the amount authorized in Section 2 of this bond ordinance and to use proceeds to pay or reimburse expenditures for the costs of the purposes described in Section 3 of this bond ordinance. This Section 10 is a declaration of intent within the meaning and for purposes of Treasury Regulations §1.150-2 or any successor provisions of federal income tax law.

SECTION 11. The Township Chief Financial Officer is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of obligations of the Township and to execute such disclosure document on behalf of the Township. The Township Chief Financial Officer is further authorized to enter into the appropriate undertaking to provide secondary market disclosure on behalf of the Township pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the "Rule") for the benefit of holders and beneficial owners of obligations of the Township and to amend such undertaking from time to time in connection with any change in law, or interpretation thereof, provided such undertaking is and continues to be, in the opinion of a nationally recognized bond counsel, consistent with the requirements of the Rule. In the event that the Township fails to comply with its undertaking, the Township shall not be liable for any monetary damages, and the remedy shall be limited to specific performance of the undertaking.

SECTION 12. The Township covenants to maintain the exclusion from gross income under section 103(a) of the Code, of the interest on all bonds and notes issued under the Original Ordinance, as amended and supplemented hereby.

SECTION 13. Except as expressly amended hereby, the Original Ordinance shall remain in full force and effect.

SECTION 14. This bond ordinance shall take effect twenty (20) days after the first publication thereof after final adoption, as provided by the Local Bond Law.

A motion by Hoyer, seconded by Bergenfeld to open the floor to public comment on Ordinance 07, 2022 was unanimously approved by voice vote.

Kyle Osgood of 139 Rocktown-Lambertville Road came forward and asked if the amendment was due to equipment costs. Mayor Cally explained the increase is due to the overall cost of the project.

Seeing no other members of the public who wished to speak on Ordinance 07, 2022, Mayor Cally closed the floor to public comment.

A motion by Hoyer, seconded by Dale to adopt Ordinance 7, 2022 upon second reading was unanimously approved by roll call vote.

Introduction: Ordinance 08, 2022 – AN ORDINANCE AMENDING THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WEST AMWELL IN THE COUNTY OF HUNTERDON, STATE OF NEW JERSEY TO AMEND CHAPTER 109, “LAND DEVELOPMENT,” PART 10 “CANNABIS” ARTICLE XLIII “CANNABIS RELATED BUSINESSES” TO REVISE LIMITATION REGULATIONS

Mayor Cally noted that the Committee received suggested amendments to the ordinance from resident Megan Hudson today, and stated Ordinance 08, 2022 will be tabled in order to provide the Committee with sufficient time to review all of the proposed changes. He commented that the ordinance will be listed on a future agenda for possible introduction.

Deputy Mayor Hoyer gave kudos to Ms. Hudson on her suggested amendments noting many of them were along the lines of what the Committee had proposed.

Holly Abitz of 201 Rock Road West spoke up from the public asking about outdoor cultivation of cannabis. Mayor Cally noted he could not comment on the matter since the ordinance was tabled.

NEW BUSINESS/OTHER

Authorization: Quote from General Code to Codify the 2021 Ordinances

It was noted for the record that the Committee authorized the \$5295.00 expense for the 2021 ordinance codification.

Approval: Fireman’s Association Membership – L. Snyder

The Committee approved Luke Snyder’s application for membership into the Firemen’s Association.

Approval: Request to Extend Conditional Use Approval Allowing Temporary Trailer on Block 47 Lot 1

The Committee authorized the existing trailer on Block 47 Lot 1 to remain on site through September 2023.

Discussion: Utilizing Open Space Lot for Community/Neighborhood Gathering (*Estates at WA*)

It was noted for the record that the Committee supported the Estates at West Amwell holding a community/neighborhood BBQ event in the open space area off of Music Mountain Boulevard.

Discussion: Email 10/3/22 from Parker McCay, re: NJDEP Tier “A” Designation Representation

The Committee noted they were not interested in being represented by Parker McCay regarding the NJDEP’s reassignment of the municipality from a Tier “B” to a Tier “A.” Attorney Pandos commented that West Amwell already filed their own administrative appeal on the matter.

SPECIAL PRESENTATION(S)

Reports by Department Heads

OEM Director Harry Heller came forward and provided a status update on the current FEMA projects noting he has reached out to try and get the \$26,000 difference for the Rocktown-Lambertville Road project and the costs for debris removal from Tropical Storm Ida have advanced to review status with FEMA. Lastly, Director Heller commented that there is a scheduled meeting on 10/11/22 with FEMA regarding the Swan Creek/Quarry Street project.

STANDING COMMITTEE REPORTS

- A. Open Space: No report was given.
- B. Environmental: No report was given.
- C. Ag Advisory: Mayor Cally commented the Ag Committee has agreed to join forces with the Open Space Committee and suggested the merger become official at the Township Committee’s 2023 reorganization meeting.
- D. Finance Committee: No report given.

OPEN TO THE PUBLIC

A motion by Hoyer, seconded by Bergenfeld to open the floor to public comment was unanimously approved by voice vote.

Megan Hudson of 328 Rocktown-Lambertville Road came forward and confirmed there were no new cannabis development applications. Mayor Cally said no. Additionally, she highlighted her suggested amendments to the existing cannabis ordinance with Committeeman Dale commenting that she do more “homework” on the matter. Ms. Hudson noted she had done extensive research on the issue and stressed the importance of the Committee doing more than just the minimum requirements to protect the Township.

Holly Abitz of 201 Rock Road West came forward and asked if a farmer can break up his property in order to grow cannabis. Several Committee members explained that the property owner would have to give up their farmland assessment. They noted that a resident had proposed such an idea but that it was not supported.

Ms. Abitz also asked if there were any new cannabis development applications. Deputy Mayor Hoyer said no.

Emily Deadwyler of 107 Snyderstown Road in East Amwell came forward and asked what the taxes would be on a 30 acre parcel in West Amwell that is not farmland assessed. She stated her point is that there may be someone willing to give up their farmland assessment in order to grow cannabis because there is so much money in the industry. Ms. Deadwyler commented that the safest choice would have been for the Township to opt out of cannabis. Lastly, she noted she emailed the link to cannabis podcasts and encouraged the Committee to listen to them.

Holly Abitz of 201 Rock Road West came forward again and asked what the reasoning was for the cannabis ordinance to allow an unlimited number of facilities. Mayor Cally explained that since the State was limiting the number of licenses, the number of facilities seemed to be self-limiting.

Mike Gruwal of 1738 Linvale-Harbourton Road commented that there are 37 cannabis licenses in the State of NJ.

Dave Beaumont of 205 Rock Road West came forward and expressed concern over the safety on Rock Road West due to the potential increase in traffic from the approved cannabis facility. He noted various inconsistencies in the ordinances and mentioned locations where stop signs are missing.

Mayor Cally remarked that the Planning Board is doing a Master Plan review and he suggested Mr. Beaumont pass his research along to them for consideration.

Seeing no other members of the public come forward, a motion was made by Dale and seconded by Bergenfeld to close the floor to public comment. The motion was unanimously approved by voice vote.
