WEST AMWELL TOWNSHIP COMMITTEE MEETING May 19, 2021 Regular Meeting – 7:30 PM

CALL TO ORDER AND STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The regularly scheduled meeting of the West Amwell Township Committee was called to order at 7:30 PM. Present were Mayor Stephen Bergenfeld, Deputy Mayor James Cally, Committeemen John Dale, Gary Hoyer and Lucas Lyons along with Township Clerk Maria Andrews and Township Attorney Katrina Campbell.

Clerk Andrews announced that this meeting is called pursuant to the provisions of the Open Public Meetings Act. Notice of this meeting was faxed to the Hunterdon County Democrat and Trenton Times on January 14, 2021, was posted on the bulletin board in the Municipal Building on that date and has remained continuously posted as required under the Statute. A copy of this notice is and has been available to the public and is on file in the office of the Township Clerk.

AGENDA REVIEW BY TOWNSHIP CLERK

Clerk Andrews noted there were no changes to the posted agenda.

PRESENTATION OF MINUTES

A motion by Hoyer, seconded by Dale to approve the Committee's 5/5/21 open and closed session minutes, with no revisions noted was unanimously approved by voice vote.

OPEN TO THE PUBLIC/TOPICS NOT ON THE AGENDA

Mayor Bergenfeld opened the floor to public comment. Michael Ehrenreich of 1874 River Road came forward and explained he is currently operating Big Bear Gear business on the property and working on a barn renovation at 1872 River Road. He noted that while he owns both properties, which are adjoining, he is not utilizing the barn property to operate his business. Big Bear Gear rents kayaks, bicycles and canoes for people to use on the Delaware River. He also is expanding to include river tubing and conducts some events and "how to" classes on the site. Mr. Ehrenreich was attending the meeting this evening to get permission from the Committee to host music festivals in July and August.

It was noted for the record that Township Zoning Officer Latini had originally approved a zoning permit to allow the kayak and canoe rentals but that inspections and approvals through the Construction and Zoning Offices had ceased with Zoning Officer Latini recently directing Mr. Ehrenreich to seek site plan approval for his expanding business and projects.

Mayor Bergenfeld commented that he agreed with Zoning Officer Latini that a site plan was needed so the Committee knew where on the property the events were taking place and to ensure there was adequate parking, lighting and bathroom/port-a-potty facilities. Mayor Bergenfeld remarked he did not feel comfortable approving any permits for music festivals at this time. Deputy Mayor Cally supported Mayor Bergenfeld's sentiments.

There was some additional discussion with Mr. Ehrenreich clarifying that the music events will be small gatherings of 50 people for some local musicians. He indicated he was not serving any food, but stated he planned to have a campfire for people to make smores. He noted tickets will be sold for each event and will be \$5.

Committeemen Hoyer, Dale and Lyons each remarked that they took no issue with authorizing the July 3, 2021 and July 10, 2021 music festival permits noting future permit requests would only be considered if there were no complaints or reported issues to the police regarding the events on the 3rd or 10th and noting that Mr. Ehrenreich will need to submit a site plan application as soon as possible or provide a status update on why an application hasn't been submitted in a timely fashion.

John Siliverdes of the Amwell Diner came forward and referred to the Route 31 Redevelopment study recently discussed at the Planning Board. He commented it is conflicting with references to rehabilitation vs. redevelopment and he stated his parents have worked/owned/operated the diner for 32 years and recently put a new roof on the building, and upgraded the plumbing and HVAC. He expressed concern that the study makes no mention of the upgrades. Mr. Siliverdes also noted the County inspected their septic system last week and found no issues. He commented that he is offended by the redevelopment report.

Attorney Campbell clarified that the Township wanted to explore this section of Route 31 for potential viable business options and she explained that if the Diner is part of the study it is not necessarily a bad thing, noting it may even increase the value of the property because it allows for other development options or uses.

John Hoff of 1721 Linvale-Harbourton Road came forward and commented that he found the Route 31 Redevelopment Study to be "woefully inadequate," noting it does not contain an appendix and he expressed concern that the Township is making decisions on a report that is not adequate or thorough.

Hearing no other members of the public speak up, Mayor Bergenfeld closed the floor to public comment.

SPECIAL PRESENTATIONS

SHRHS Referendum Plan by Superintendent A. Suozzo

High School Superintendent Anthony Suozzo gave a 45 minute Power Point presentation on the proposed \$27.5 million referendum. If approved, the outcome would be renovations to Lambertville Public School creating a district Pre-K through 4^{th} Grade school and a newly constructed $5^{th}-8^{th}$ grade "green" school.

Superintendent Suozzo highlighted the curriculum expansion would include upgrades to: Computer science, podcast electives, pre-engineering classes, academic transitioning for special needs students, a redesigned library and media center and a TV, film and video production elective.

It was noted that any renovations to the High School would be done out of the school budget and would not be part of the referendum.

Lastly, Superintendent Suozzo noted educational equality, expanded mental health support, additional extra-curriculars and meeting the projected enrollment needs are all benefits of the referendum passing. The fiscal benefits were noted as reduced operational and transportation costs as well as decreased salary expenses as teachers retire and would not all need to be replaced.

The Committee thanked Superintendent Suozzo for a terrific presentation. Mayor Bergenfeld opened the floor to any questions or comments from the public.

Marilee Adams of 161 Rocktown-Lambertville Road came forward and expressed potential noise and traffic concerns as well as concerns over water pressure. Superintendent Suozzo noted Tom Stover will be doing all of the well testing and is currently working with a geologist. He also clarified that construction would be estimated to start in September of 2022 with a projected 2 year completion sometime in January 2024.

Mayor Bergenfeld inquired how the increased costs for construction materials will be accounted for. Superintendent Suozzo noted that if BIDS came in higher than the estimated cost they would have to go out to vote/referendum again.

Dave Beaumont of 205 Rock Road West noted that this referendum is the last step toward the goals outlined in the regionalization years ago.

DPW Director Rollero thanked the Committee for the Proclamation on this evening's agenda and updated the Committee on the following projects:

- 1. Rocktown-Lambertville Road Phase IV will be going out to BID and will need to be awarded at the 6/16/21 Committee meeting
- 2. Paved 1700 linear feet of Bowne Station Road, an "in-house" paving job
- 3. 50,000 sq. yards of chip seal will be done on Alexauken Creek Road, Bowne Station Road, Cedar Crest and Woodward Lane/Jefferson Road

<u>Chapter 88 Amendments – Fire Safety Official: P. Langon</u>

It was noted for the record that Mr. Langon could not make tonight's meeting and the discussion will be listed on the Committee's 6/16/21 agenda.

<u>Presentation of Emergency Operating Plan – H. Heller</u>

OEM Director Harry Heller presented the Emergency Operations Plan and explained the municipality is required to have it and stated the Committee needs to sign off on it this evening. Director Heller also wanted the record to reflect his appreciation for all of the work Amanda Burd did on the plan. Lastly, Director Heller informed the Committee that he attended a recent FEMA webinar where it was apparent they are changing the requirements regarding the release of the COVID funding.

Attorney Campbell noted she needed to review the paperwork because she believed the existing solar panels on the Township property may make the municipality ineligible for this program.

Discussion: Posting Protocol for the Township Website

Attorney Campbell commented on Daniel's Law which will soon prohibit the posting/release of Judge's names, law enforcement officers and others. She noted that the Tax Assessor uses his personal website to scan and post township documents like farmland forms and she commented that the Township must have a posting protocol to avoid potential issues. The Committee authorized Attorney Campbell to speak with the Tax Assessor about this matter.

OPEN TO THE PUBLIC

Mayor Bergenfeld opened the floor to public comment. Dave Beaumont of 205 Rock Road West came forward and remarked that after last night's Planning Board meeting on the proposed Dollar General application, there needs to be some community outreach. He also asked about the proposed school referendum. Mayor Bergenfeld stated the Committee will not publically take a position on the referendum due to the issue with the school board voting members. Lastly, Mr. Beaumont inquired about the trails and public right-of-ways within the Township and asked under who's purview they fall. Mayor Bergenfeld remarked that the Township Committee has no interest in creating or maintaining any trails.

Hearing no other members of the public speak up, Mayor Bergenfeld closed the floor to public comment.

TOWNSHIP OF WEST AMWELL HUNTERDON COUNTY

A RESOLUTION DETERMINING THAT THE PROPERTIES IDENTIFIED AS BLOCK 21, LOTS 13, 14, 14.01, 15, 16, 17, 18 AND 19 AND BLOCK 23, LOTS 1, 3, 4, 5, 6, 9, 10, 10.01, 10.02, 11, 12 AND 13 BE DESIGNATED AS A NON-CONDEMNATION REDEVELOPMENT AREA IN ACCORDANCE WITH THE LOCAL REDEVELOPMENT AND HOUSING LAW, N.J.S.A. 40A:12A-1 ET SEQ.

WHEREAS, the Local Redevelopment and Housing Law, <u>N.J.S.A.</u> 40A:12A-1 <u>et seq.</u> ("Redevelopment Law"), authorizes municipalities to determine whether certain parcels of land located therein constitute areas in need of redevelopment; and

WHEREAS, pursuant to Resolution No. 97- 2020 adopted on December 2, 2020 (as amended by Resolution No. 39-2021 adopted on April 7, 2021), the Township Committee ("Committee") of the Township of West Amwell (the "Township") authorized and directed the Planning Board of the Township of West Amwell (the "Board") to conduct an investigation to determine whether certain properties, identified as Block 21, Lots 12, 12.02, 13, 14, 14.01, 15, 16, 17, 18 and 19 and Block 23, Lots 1, 3, 4, 4.01, 5, 6, 9, 10, 10.01, 10.02, 11, 12, 13, 28 and 32, or any portions thereof (the "Study Area"), meet the criteria set forth in the Redevelopment Law and should be designated as a Non-Condemnation Redevelopment Area, as that term is defined by the Redevelopment Law; and

WHEREAS, the Board conducted an investigation of the Study Area to determine whether it should be designated as a Non-Condemnation Redevelopment Area in accordance with the criteria and procedures set forth in N.J.S.A. 40A:12A-5 and 40A:12A-6; and

WHEREAS, as part of its investigation, the Board directed Charles Latini, P.P., AICP, to prepare an Area In Need of Redevelopment Investigation Study ("Area in Need Study") for the Board for its consideration in determining whether the Study Area should be designated a Non-Condemnation Redevelopment Area entitled "REDEVELOPMENT AREA DETERMINATION REPORT – Route 31 and 579 Redevelopment Area;" and

WHEREAS, Mr. Latini recommended that Block 21, Lots 13, 14, 14.01, 15, 16, 17, 18 and 19 and Block 23, Lot 1, 3, 4, 5, 6 and 9 be included in the Redevelopment Map area included in the Redevelopment Plan and that Block 23, Lots 10, 10.01, 10.02, 11, 12 and 13 be included in the Rehabilitation Map area included in the Redevelopment Plan; and

WHEREAS, the Area in Need Study included a map prepared by Mr. Latini showing the boundaries of the proposed redevelopment area and locations of the parcels included therein, along with a statement setting forth the basis for its investigation in accordance with N.J.S.A. 40A:12A-6(b)(1); and

WHEREAS, the Board conducted a public hearing on May 11, 2021, with notice having been properly given pursuant to N.J.S.A. 40A:12A-6(b)(3); and

WHEREAS, at the public hearing, the Board reviewed the Area in Need Study and heard testimony from Mr. Latini and others; and

WHEREAS, at the public hearing, members of the general public were given an opportunity to be heard and to address questions to the Board and Mr. Latini concerning the potential designation of the Study Area as a Non-Condemnation Redevelopment Area; and

WHEREAS, after completing its investigation and public hearing on this matter, the Board concluded that there was sufficient credible evidence to support findings that satisfy the criteria set forth in the Redevelopment Law, particularly at N.J.S.A. 40A:12A-5 et seq., for designating the Study Area as a Non-Condemnation Redevelopment Area and that said designation is necessary for the effective redevelopment of the area comprising the Study Area; and

WHEREAS, the Board further concluded that there was sufficient credible evidence to support findings that any designation of the Study Area as a Non-Condemnation Study Area shall not authorize the municipality to exercise the power of eminent domain to acquire any property in the Study Area; and

WHEREAS, in accordance with the Redevelopment Law and as approved by Motion, dated May 11, 2021, the Board recommended to the Township Committee that Block 21, Lots 13, 14, 14.01, 15, 16, 17, 18 and 19 and Block 23, Lot 1, 3, 4, 5, 6, 9, 10, 10.01, 10.02, 11, 12 and 13 be designated as a Non-Condemnation Redevelopment Area; and

WHEREAS, the Board recommended that Block 21, Lots 12 and 12.01 and Block 23, Lots 28 and 32 be excluded from such designation as they did not meet the requirements of the Redevelopment Law; and

WHEREAS, the Township Committee considered the Board's recommendation at its regularly scheduled public meeting on May 19, 2021; and

WHEREAS, at the Township Committee's public meeting, members of the general public were given an opportunity to be heard and to address questions concerning the potential designation of the Study Area as a Non-Condemnation Redevelopment Area; and

WHEREAS, Township Committee accepted the recommendation of the Board to declare a portion of the Study Area (Block 21, Lots 13, 14, 14.01, 15, 16, 17, 18 and 19 and Block 23, Lot 1, 3, 4, 5, 6, 9, 10, 10.01, 10.02, 11, 12 and 13) as a Non-Condemnation Redevelopment Area; and

WHEREAS, in order to effectuate the Township Committee's designation of the Study Area as an Area in Need of Redevelopment, the preparation of a Redevelopment Plan and presentation to the Planning Board and Township Committee is required; and

WHEREAS, the Township Committee desires to authorize Mr. Latini to draft a Redevelopment Plan in consultation with the Board and to authorize the Board to review the Redevelopment Plan and transmit the proposed Plan to the Township Committee for its consideration upon completion of the Planning Board's review.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of West Amwell, County of Hunterdon, State of New Jersey as follows:

That the Township Committee accepts the recommendation from the Planning Board of the Township of West Amwell and finds that Block 21, Lots 13, 14, 14.01, 15, 16, 17, 18 and 19 and Block 23, Lot 1, 3, 4, 5, 6, 9, 10, 10.01, 10.02, 11, 12, 13 as shown on the official tax map of the Township of West Amwell be and are hereby deemed to be a Non-Condemnation Redevelopment Area pursuant to the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 et seq.; and

That the designation of Block 21, Lots 12 and 12.01 and Block 23, Lots 28 and 32 as a Non-Condemnation Redevelopment Area shall not authorize the Township to exercise the power of eminent domain to acquire any property in the Study Area; and

That the Township hereby reserves all other authority and powers granted to it under the Redevelopment Law; and

That the Clerk of the Township of West Amwell shall forthwith transmit a copy of the within Resolution to the Commissioner of the Department of Community Affairs for review; and

That within ten (10) days of the Township Committee's adoption of the within Resolution, the Clerk of the Township of West Amwell shall serve notice of the Township Committee's determination and the within Resolution upon all record owners of property within the Non-Condemnation Redevelopment Area, those whose names are listed on the tax assessor's records, and upon each person who filed a written objection thereto and stated, in or upon the written submission, an address to which notice of the determination and Resolution may be sent and upon the Commission of the New Jersey Department of Community Affairs; and

That Charles Latini, P.P., A.I.C.P., having been previously retained by the Township, is authorized and directed to prepare a Redevelopment Plan for Block 21, Lots 13, 14, 14.01, 15, 16, 17, 18 and 19 and Block 23, Lot 1, 3, 4, 5, 6, 9, 10, 10.01, 10.02, 11, 12, 13, including an outline for the planning, development and redevelopment of the Study Area pursuant to N.J.S.A. 40A:12A-7 and present same to the Planning Board and Township Committee at the hourly rate stated in his proposal; and

That the Planning Board shall transmit a report containing its recommendation concerning the Redevelopment Plan to the Township Committee. The Planning Board's report shall include an identification of any provisions in the proposed Redevelopment Plan which are inconsistent with the Master Plan and recommendations concerning these inconsistencies and any other matters as the Planning Board deems appropriate; and

That this Resolution shall take effect immediately.
