# WEST AMWELL TOWNSHIP COMMITTEE MEETING June 16, 2021 Regular Meeting – 7:30 PM

# CALL TO ORDER AND STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

# Reports by Department Heads

# Update from DPW Director R. Rollero

DPW Director Rollero updated the Committee on the following items:

- 1. Rocktown-Lambertville Road Improvement Project Phase IV will be awarded to DeSantis Construction
- 2. Resolution #57-2021 on this evening's agenda will cover asphaltic surface treatment in the amount of \$104,074.53 for Alexauken Creek Road, Bowne Station Road, Woodward Lane/Jefferson Road and Cedar Crest Road
- 3. The residential mulch delivery program is a success with 9 deliveries in 2021 totaling \$1875 which is an increase over last year's revenue
- 4. The bulk/oversized item punch card program will be rolled out July 1<sup>st</sup> with the new season's trash card permits. Each new trash card will come with 2 free bulk item punches to familiarize residents with the program. An additional bulk card can be purchased for \$40 which will allow for 5 extra bulk items/punches.

- 5. There was some discussion on the Hewitt Park rental fee with the Committee deciding to increase the amount to a \$100 non-refundable fee for anyone who rents the park.
- 6. The Township received a NJ Clean Communities Grant in the amount of \$12,530.20 with Director Rollero noting he would like to utilize the funds for the 4<sup>th</sup> Annual Delaware River Clean-up on 9/18/21 and also for the removal of graffiti from the Goat Hill Overlook George Washington Rock on 9/25/21. It was noted for the record that the Committee supported these efforts.

# Chapter 88 Amendments – Fire Safety Official: P. Langon

The Committee asked Mr. Langon for his interpretation of Chapter 88-8: Required Inspections, permits and fees. After some discussion it was agreed that the language for letter (A) should be changed to read, "All structures, except one- or two- family owner-occupied properties, one- or two- family rentals properties and agricultural buildings, shall be inspected annually." The fee for each building or structure at least 1000 square feet or more shall be \$60.

Mr. Langon confirmed that every business in the Township is inspected annually. Deputy Mayor Cally commented that he would like to see a complete list of businesses with a regimented annual scheduling of inspections.

Mr. Langon remarked that he would like to change the language in the ordinance from "inspection fee" to "annual registration fee" so he can send bills out. He explained if the bill is paid he will conduct the inspection, if it isn't paid within 30 days the fee would double. Attorney Campbell clarified that the way the ordinance is currently written, the billing goes out after the inspection is done. The Committee agreed to leave the ordinance as written.

# <u>Resolution #64-2021: RESOLUTION AUTHORIZING THE SALE OF CERTAIN LAND AND PROPERTY NO</u> LONGER NEEDED FOR PUBLIC USE BY THE TOWNSHIP OF WEST AMWELL PURSUANT TO N.J.SA. 40A:12-13(B)

#### Resolution #64-2021

WHEREAS, the Township of West Amwell is the owner of certain vacant undersized lands within the Township; and

WHEREAS, the Township Committee of the Township of West Amwell does hereby determine that the lands and properties set forth in Schedule A are no longer needed for public use; and

WHEREAS, the Township desires to make available for sale in accordance with the Local Lands and Buildings Law; and

WHEREAS, <u>N.J.S.A</u>. 40A:12-13(b) requires the Township to provide the owner or owners of any real property contiguous to such real property the right to prior refusal to purchase such land.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Washington, in the County of Warren State of New Jersey, as follows:

The lands listed on the attached Schedule A shall be offered for private sale to the contiguous property owners pursuant to the statute.

A minimum bid for each property is listed on Schedule A.

All contiguous property owners shall receive a letter from the Township offering the property for sale at the minimum bid price. Contiguous property owners shall be instructed to submit a sealed offer to the Township no later than July 9, 2021 with their highest and best offer.

The Township shall consider all offers at its July 21, 2021 meeting and at that time select the highest bidder for each property. The Township reserves the right to reject all bids for a property or remove a property or properties from Schedule A at any time prior to the award of the contract.

The winning bidders shall be given one week to deposit 10% of their purchase price with the Township and execute a contract for sale.

It shall be a condition of the sale that the lots purchased be merged by the tax assessor into the purchasers existing contiguous lot.
