Mayor Cally presented Ms. Reischman with the Proclamation and congratulated her on her achievement.

PRESENTATION OF MINUTES

It was noted for the record that the Committee's 6/15/22 minutes will be listed on the 8/17/22 agenda for approval.

OPEN TO THE PUBLIC/TOPICS NOT ON THE AGENDA

Mayor Cally opened the floor to public comment.

Bob Petrus of 10 Wilson Road came forward and asked if there will be any consideration given to revise the cannabis ordinances based on all of the push back over the GMNJ application. Mayor Cally suggested that anyone who wished to provide possible amendments to the ordinances should forward the information to the Township Clerk who will give it to the Committee for review.

Holly Abitz of 201 Rock Road West came forward and asked why GMNJ wasn't asked to secure a bond in the event resident's wells go dry. Mayor Cally stated that the Board considered a bond but ultimately decided upon draw down/stress testing for surrounding wells. Ms. Abitz commented that she is concerned West Amwell is going to turn into a "Flint Michigan" or "Dupont" situation. Mayor Cally noted that GMNJ will be regulated by the State and remarked there should be nothing going into the ground. Deputy Mayor Hoyer added that corporations have liability insurance for these reasons.

Dan Longhi of 14 Mountainview Road came forward and remarked he believes a lot of things were not considered for a facility such as GMNJ's and noted the multiple mini blackouts in the Township over the past 24 hours.

Meghan Hudson of 328 Rocktown-Lambertville Road stated there is no data on water output regarding the GMNJ site, specifically what will be trucked off site. She asked if it is possible to get time on the agenda for next month's meeting to discuss amending the cannabis ordinances. Mayor Cally again suggested that anyone who wished to provide possible amendments to the ordinances should forward the information to the Township Clerk who will give it to the Committee for review.

Emily Deadwyler of 107 Snydertown Road came forward and commented that the back-up generator on the GMNJ site will be very noisy.

Mayor Cally noted that JCP&L is investigating the brown outs occurring in the Township.

Holly Abitz of 201 Rock Road West came forward again and expressed that she is trying to understand the financial impact of GMNJ and asked how the Township will know they are getting the right numbers/financials from them. Mayor Cally explained the Township will have the opportunity to review the figures every two years. Ms. Abitz asked if taxes will go down. Mayor Cally said the Committee is trying to "hold" taxes.

Seeing no other members of the public come forward, Mayor Cally closed the floor to public comment.

WHEREAS, it is widely recognized that mental health issues are at the core of the numerous violent events around the nation, where so many have been randomly killed, wounded, or traumatized and that one of the key factors in preventing violent actions from occurring in the first place is to provide greater access to mental health services that includes breaching the barrier of the stigma associated with mental illness, and

WHEREAS, while a very small percentage of those in need of mental health care will ever turn violent, the stigma associated with the disease of mental illness is identified as the primary reason individuals fail to seek the help they need to recover from the disease, and

WHEREAS, Stigma-Free Communities aim to inspire public interest and open dialogues about stigma, raise awareness of the disease of mental illness, and create a culture wherein residents who have the disease of mental illness feel supported by their community and neighbors, and feel free to seek treatment for the disease without fear of feelings of shame or disgrace, being stigmatized, and

WHEREAS, the Governing Body of West Amwell Township wishes to lead our community in recognizing the need to eliminate the stigmatization of mental illness by designating West Amwell Township as a Stigma Free community, promoting awareness that there can be no "health" without mental health, breaking down barriers, and encouraging residents of all ages to be mindful of their mental health and to ask for help when needed, so recovery can begin, hope is inspired, and tragedies are avoided,

NOW THEREFORE BE IT RESOLVED that the West Amwell Township Committee hereby designates West Amwell as a Stigma-Free Community, raising awareness of the resources available and encouraging those who may have need for mental health services to engage in care, as soon as the need is identified, and for all residents to demonstrate compassion, understanding, and support through the elimination of the stigma towards those living with mental illness,

BE IT FURTHER RESOLVED that West Amwell Township joins with Hunterdon County and many of the communities in the county in becoming Stigma Free By '23.

Resolution #71-2022: Authorizing Temporary Cell Tower on Block 17 Lot 15

Resolution #71-2022 TOWNSHIP OF WEST AMWELL HUNTERDON COUNTY RESOLUTION AUTHORIZING THE CONSTRUCTION OF A TEMPORARY WIRELESS COMMUNICATION FACILITY ON PROPERTY LOCATED AT BLOCK 17, LOT 15, COMMONLY KNOWN AS 99 ROCKTOWN-LAMBERTVILLE ROAD

WHEREAS, the Township of West Amwell ("Township") is desirous of promoting the establishment of robust and uninterrupted telecommunication services within the Township to protect the public safety, health, and general welfare of the community, such that emergency and other essential services may be readily accessible; and

WHEREAS, Cellco Partnership d/b/a Verizon Wireless ("Verizon Wireless") currently operates a wireless communication facility on an existing Public Service and Gas ("PSE&G") electric transmission tower located at 1469 Route 179 and designated as Block 3, Lot 16 on the official Tax Maps of the Township of West Amwell; and

WHEREAS, PSE&G has provided notice to Verizon Wireless that it is decommissioning the electric transmission tower upon which the Verizon Wireless communication facility is located, and that Verizon Wireless must accordingly decommission its wireless communication facility prior to approximately August 26, 2022; and

WHEREAS, it is the intention of Verizon Wireless to relocate its wireless communication facility back onto the electric transmission tower at such time as PSE&G completes construction of a new replacement electric transmission tower; and

WHEREAS, Verizon Wireless also operates a wireless communication facility on an existing PSE&G electric transmission tower on property located off Old Route 518 West and designated as Block 28, Lot 1.01; and

WHEREAS, PSE&G has provided notice to Verizon Wireless that it is also decommissioning this electric transmission tower upon which Verizon Wireless currently operates its wireless communication facility, and that Verizon Wireless must accordingly decommission its wireless communication facility on this electric transmission tower prior to January, 2023; and

WHEREAS, it is the intention of Verizon Wireless to relocate its wireless communication facility back onto this electric transmission tower when PSE&G completes construction of a new replacement electric transmission tower; and

WHEREAS, during the time period for each of the above noted sites that Verizon Wireless is being required to decommission its wireless communication facility pending relocation back onto the completed reconstructed electric transmission towers, Verizon Wireless is required to provide continued reliable wireless communication services to the Township of West Amwell and surrounding geographic areas; and

WHEREAS, the Township of West Amwell Police Department and other responding agencies utilize Verizon Wireless service in furtherance of their duties to provide vital emergency services to the community; and

WHEREAS, the federal government has declared a public need for wireless communication services as a means to protect public safety and property through the use of wireless services; and

WHEREAS, Verizon Wireless has identified certain property located at 99 Rocktown-Lambertville Road and designated as Block 17, Lot 15 on the official Tax Maps of the Township of West Amwell ("Subject Property") as certain property upon which it wishes to construct a temporary wireless communication facility ("Temporary Facility") in accordance with the attached "Exhibit A" for a period of one (1) year from the date of commencement of its operation; and

WHEREAS, it is critical as a matter of public health, safety, and welfare to provide continued reliable wireless communication service during such time as Verizon Wireless cannot utilize each of the above-referenced PSE&G electric transmission towers; and

WHEREAS, the construction of a Temporary Facility at the subject property will critically obviate the need for two temporary wireless communication facilities by virtue of its location centrally located between the two existing PSE&G current sites; and

WHEREAS, in order to provide the critical continued wireless communication services, the Township finds that a waiver of formal zoning approval is essential as a matter of public health, safety, and general welfare; and

WHEREAS, the Township, by virtue of all of the foregoing, and in accordance with the powers vested in the Mayor and Township Committee pursuant to <u>N.J.S.A.</u> 40A:63-5, 6, authorizes the installation of the Temporary Facility on an emergent basis.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of West Amwell, County of Hunterdon, State of New Jersey as follows:

1. Verizon Wireless is hereby granted on an emergent authorization basis the right to obtain all required zoning permits and building permits from the Township Zoning Official and Construction Code Official without the requirements for formal land use Planning or Zoning Board approval, subject to the obligation of Verizon Wireless to comply with all other applicable building code provisions and the approval of such other governmental agencies as may be required.

2. The right to maintain the temporary wireless communication facility at the subject property shall be for a period of one (1) year, subject to the right of Verizon Wireless to obtain a reasonable extension of said time, if it proves to the reasonable satisfaction of the Township Committee that it has been delayed in relocating to the PSE&G electric transmission tower based on delays in completion of the electric transmission tower. The one (1) year time period shall run from the date that the temporary wireless communication facility is deemed operational.

3. This Resolution shall take effect immediately.

INTRODUCTION/PUBLIC HEARING ON ORDINANCES

It was noted for the record that there were no ordinances listed on the agenda for action.

UNFINISHED BUSINESS

<u>Status of Resolution Requesting County Superintendent to Investigate the Advisability of the</u> <u>Municipality Withdrawing from the all Purpose SHRSD</u>

Attorney Pandos noted the following process regarding potential de-regionalization:

1. A resolution petitioning the County Superintendent to commission a feasibility study

- 2. The Township Committee then decides how they wish to proceed
- 3. The State must approve the de-regionalization

4. The de-regionalization question goes on the ballot for the voters to decide

Mayor Cally commented that he would like input from the County Superintendent on both possibilities: "Full" and/or "Partial" de-regionalization.

Meghan Hudson of 328 Rocktown-Lambertville Road spoke up from the public and asked if parents would be able to select their children's school. Mayor Cally stated he did not know how enrollment would be determined.

Dave Beaumont of 205 Rock Road West spoke up from the public and clarified that the proper term is "withdrawal" not "de-regionalization" and he remarked that only West Amwell would withdrawal in some form, not Lambertville and Stockton.

Lieutenant Skillman referenced the quote that was provided by GTBM and stated many municipalities are moving toward E-Tickets because it is more efficient. OEM Director Harry Heller provided an update on the USDA storm recovery funding saying the Township was approved for \$134,268.75.

DPW Director Ryan Rollero provided a road update highlighting the following details:

- 1. Mountain View Development, Woodens Lane, Barry Road and Rocktown-Hill Road will all have portions of the roadways resurfaced
- 2. The Mt. Airy Village Road Improvement Project will be going out to BID soon and the Rocktown-Lambertville Road Phase IV Project is pending
- 3. This year 328 garbage permits have been sold = \$65,600 in revenue

OPEN TO THE PUBLIC

A motion by Hoyer, seconded by Dale to open the floor to public comment was unanimously approved by voice vote.

Tayab Ansari of 32 Barry Road came forward and asked why the chip sealing on his road can't be extended. Director Rollero explained the chip seal process cannot be applied to stone roads, only paved ones. Committeeman Bergenfeld added that the Committee has no intention of paving all of Barry Road.

Dave Beaumont of 205 Rock Road West came forward and referred to the email he sent the Planning Board expressing concern over potential traffic from the GMNJ property. Mayor Cally noted the Board requested directional signage be put up preventing people from making a left out of the facility.

Emily Deadwyler of 107 Snydertown Road, Hopewell came forward and inquired about the Cannabis Advisory Committee. Mayor Cally noted it has not been formed yet but explained it will consist of 2 Township Committee members, up to 2 residents and the Zoning Officer.

Ms. Deadwyler then asked if any cannabis applicants have requested a letter of support in the past 2 months. Mayor Cally said no.

Dan Longhi of 14 Mountainview clarified that the Cannabis Review Committee will provide input to the Township Committee regarding potential cannabis applications. Mayor Cally said yes.

Mike Gural of 1748 Linvale-Harbourton Road came forward and asked what the process is for being considered to serve on the Cannabis Review Committee. Mayor Cally suggested he submit a Citizens Leadership Form. Mr. Gural asked that the Township consider what other municipalities have done regarding cannabis.

Emily Deadwyler of 107 Snydertown Road came forward again and asked if there will be more latitude from the Township when it comes to deciding on another cannabis applicant. Mayor Cally remarked that the Committee would like potential applicants to be a "good fit" but noted they cannot discriminate. Ms. Deadwyler stated she believes the Committee has created a lot of unintended risks by allowing cannabis in the community.

Seeing no other members of the public come forward, Mayor Cally closed the floor to public comment.
