Resolution #83-2022 In Memory of Tax Assessor David M. Gill

Mayor Cally read Resolution #83-2022 into the record.

RESOLUTION #83-2022 A RESOLUTION IN MEMORY OF DAVID M. GILL September 8, 1942 – August 22, 2022

WHEREAS, the Governing Body of West Amwell Township wishes to record its deep sorrow over the passing of David M. Gill who served as the Township's Tax Assessor for 29 years; and

WHEREAS, David devoted his life to Municipal Government starting his career as a Field Tax Assessor in East Amwell Township in 1982 and then later taking on West Amwell Township, Frenchtown and Milford Boroughs in Hunterdon County as well as the Town of Belvidere, Liberty Township, Oxford Township, Washington Township, Frelinghuysen Township, Hardwick Township and Pahaquarry Township in Warren County; and

WHEREAS, prior to becoming a Tax Assessor David served in the National Guard assigned to the 4th Battalion 112th Artillery as a Battalion Clerk achieving Top Secret security clearance; and

WHEREAS, David also was a real estate investor, a retail business owner of an office furniture and supply store and a self-employed custom home builder and kitchen cabinet designer. His skills included designing and constructing the home he resided in for many decades on Mountain Road in East Amwell Township; and

WHEREAS, David was a technical wizard creating many computer programs over the years to assist with his assessing duties, but none more cherished than his "Flip Book" program for which he was most proud of; and

WHEREAS, David loved his cats, his community and his numerous co-workers often giving his old computer equipment to many fellow colleagues after purchasing the latest and greatest upgraded hard drive or monitor; and

WHEREAS, the Governing Body is grateful for David's many contributions as an outstanding citizen, friend and Assessor to our community; and

WHEREAS, David's service was given with such devotion that he has earned the respect, admiration and friendship of all the citizens in our community through his professional leadership and dedication; and

NOW THEREFORE BE IT RESOLVED that in recognition of David's contributions to the Governing Body, the Municipality and its citizens, we hereby express our deep appreciation for his service to this community and extend to his family our sincere sympathy upon his passing.

Holly Abitz of 201 Rock Road West came forward and asked for an update on the school referendum lawsuit. Mayor Cally explained that the school has bonded for the proposed project and the Township's lawsuit is in the appeal process with oral arguments scheduled for what he believes will be January.

<u>Resolution #52-2022: Resolution Requesting the County Superintendent Investigate the Advisability of</u> the Municipality Withdrawing from the all Purpose SHRSD

RESOLUTION #52-2022

A RESOLUTION OF THE TOWNSHIP OF WEST AMWELL, COUNTY OF HUNTERDON, STATE OF NEW JERSEY AUTHORIZING THE TOWNSHIP TO APPLY, PURSUANT TO N.J.S.A. 18A:13-66, TO THE COUNTY SUPERINTENDENT OF SCHOOLS TO INVESTIGATE THE ADVISABILITY OF THE FULL OR PARTIAL WITHDRAWAL OF WEST AMWELL FROM THE SOUTH HUNTERDON REGIONAL SCHOOL DISTRICT.

WHEREAS, the municipalities of West Amwell, Lambertville, and Stockton were regionalized as a limited purpose regional school district for high school only until 2014; and

WHEREAS, in 2014, the municipalities of West Amwell, Lambertville, and Stockton regionalized as an allpurpose regional school district (the "District"); and

WHEREAS, the regionalization promised each municipality a cost savings while promising each municipality representation in the decisions of the District; and

WHEREAS, the promises made to the municipalities prior to regionalization were not honored; and

WHEREAS, the representation on the Board of Education (the "Board") was set at five seats for Lambertville, three seats for West Amwell, and one seat for Stockton; and

WHEREAS, the result is a Board that only looks out for the interests of the residents of Lambertville, with little to no consideration given for the wellbeing of the West Amwell and Stockton students or for the financial implications of the residents of these two municipalities; and

WHEREAS, some Lambertville members of the Board of Education have publicly admitted that their only motivation is to only do what is in the best interest of Lambertville residents and students; and

WHEREAS, the West Amwell Township Committee is appalled at the way that some members of the Board have conducted themselves, and so the Township reached out to the Executive County Superintendent in February of 2021 asking him to review and re-adjust the school board seat allocation based upon powers provided to him under the law; and

WHEREAS, the Executive County Superintendent refused to review the allocation despite numerous instances of inappropriate and biased behavior by the Lambertville members of the Board; and

WHEREAS, the improper conduct of the Lambertville members of the Board only seemed to be exacerbated by the Township's request; and

WHEREAS, the Board put forth a \$32 Million referendum to create a school in Lambertville without considering viable options elsewhere in the District; and

WHEREAS, the Board spent taxpayer monies to put forth propaganda to support this one-sided referendum; and

WHEREAS, 72% of West Amwell residents voted against the referendum; and

WHEREAS, West Amwell is currently in litigation with the District challenging the results of the referendum; and

WHEREAS, regardless of the outcome of the referendum challenge the Township believes that the members of the Board will continue to only make decisions that benefit the residents of Lambertville; and

WHEREAS, the Board recently voted to remove Class III police officers from the District despite a majority of West Amwell and Stockton parents being in favor of providing this essential protection for our children; and

WHEREAS, the Lambertville majority of the Board once again made a decision to cater to the whim of the residents of only one sending district with a total disregard for the strong legitimate feelings of the rest of the District; and

WHEREAS, the Township of West Amwell believes that remaining part of the District is not in the best interest of the students or taxpayers of West Amwell; and

WHEREAS, N.J.S.A. 18A:13-66 provides that "the governing body of any municipality constituting a part of an all purpose regional district may, by resolution, apply to the county superintendent of schools to investigate the advisability of the withdrawal of the municipality from the all purpose regional district"; and

WHEREAS, West Amwell Township Committee believes they owe it to the residents of West Amwell to apply to the County Superintendent of Schools to investigate the advisability of a withdrawal from the regional school district.

NOW THEREFORE BE IT RESOLVED, that the Township Committee of the Township of West Amwell hereby applies, pursuant to N.J.S.A. 18A:13-66, to the County Superintendent of Schools to investigate the advisability of West Amwell Township withdrawing from the South Hunterdon Regional School District, either in full, or in part, whereby the Township would remain regionalized only as a limited purpose regional school district for high school.

Discussion: Detoured Traffic through the Township

Mayor Cally explained there has been some concern expressed over truck traffic coming through the Township due to road projects in neighboring municipalities. Attorney Pandos advised that it is not within the Committee's purview to monitor truck traffic.

SPECIAL PRESENTATION(S)

Reports by Department Heads

Fire Chief Ent came forward and updated the Committee on the following items:

1. He met with the GMNJ property owners and noted they agreed with all of the Fire Company's recommendations including the requested underground water storage tank, the water monitors and retaining permission to utilize the field for emergency helicopter landings. He also noted they will be conducting a walk through of the facility to better understand the operation.

2. Chief Ent asked for permission to install the training container at the Fire House which was discussed last year. He explained it will be a 40 ft. tall container, painted tan, and will have a roof simulator to cut panels out of for training purposes. The Committee took no issue with the proposed training trailer.

3. Chief Ent referred to the building inspection and possible renovation discussion he had with Committeeman Bergenfeld last year. He noted that now that the Ladies Auxiliary has officially moved out of the building he would like to turn the former dining room into a storage area. He plans to install two 14 ft. garage doors to house their pickup truck and gator. He requested the Township waive any permit fees associated with the renovations. The Committee supported the proposed renovations and agreed to waive the permit fees.

OEM Director Harry Heller came forward and provided a handout depicting the status of the current FEMA projects he is working on. He noted he is trying to get extra money to fund the repairs needed for all of the water erosion damage on Stymiest Road. Director Heller also noted that Engineer Burr intends to work with Viola Water Company to get them to assist with the repairs and future mitigation.

Mayor Cally noted that SUEZ Water Company was willing to cut the Township a check for the repairs on Stymiest Road prior to them being bought out by Viola.
