The West Amwell Township Committee met on the above date at 5:48 p.m. Present: Mayor Fisher, Committeemen Rich and Molnar and Clerk Olsen. Also in attendance, at various times, were Lt. Stephen J. Bartzak, Helen Laesker, Christine Rosikiewicz, Cathy Urbanski and Hal Shute.

In compliance with the Public Meetings Act, Mayor Fisher announced that this Special Meeting was called pursuant to the provisions of the Open Public Meetings Act with notices faxed to the Hunterdon County Democrat and the Trenton Times on September 5, 2012. A copy of this notice is and has been available to the public and is on file in the office of the Municipal Clerk.

The meeting was recorded via digital recording system, except for the Closed Sessions.

Whether this item is available as a State bid also needs to be determined. A meeting with the Court Administrator concerning both the process and the program has also been held with good results. Lt. Bartzak also relayed that the use of hard copy tickets will not go away as there will always be occasions with power and/or computer outages as well as areas with dead spots that block transmission. The information entered for an e-ticket goes to the main data base at the State and can be accessed by the Court Administrator through her office terminal. Also noted was that North County municipalities of Readington and Clinton are currently using this system and that West Amwell would be leading the way in the South County.

Mayor Fisher offered that forward movement should continue although money could be a challenge.

WHEREAS, the Township Engineer has advised that Orleans Homebuilders, Inc. has satisfactorily completed the work identified on the November 16, 2011 punch list, with the exception of the replacement of four trees and required paving work at the firehouse; and

WHEREAS, Township Engineer Richard Roseberry advised in his e-mail of September 5, 2012 to Township Clerk Olsen that the maintenance bonds can be released to the applicant once said cash bonds are received; and,

WHEREAS, the Orleans Homebuilders has posted cash bonds of \$1500.00 for tree replacement and \$5000.00 for paving work at the firehouse
