Resolution #74-2020: Special Assessment on Block 7 Lots 13 and 23

Resolution #74-2020

RESOLUTION OF THE TOWNSHIP OF WEST AMWELL, COUNTY OF HUNTERDON, STATE OF NEW JERSEY, AUTHORIZING THE TAX ASSESSOR TO PLACE A SPECIAL ASSESSMENT ON BLOCK 7, LOTS 13 AND 23.

WHEREAS, the New Jersey Department of Environmental Protection provided a loan pursuant to the Dam, Lake, Stream, Flood Control, Water Resources and Wastewater Treatment Project Bond Act of 2003 to, among others, the owner of Block 7, Lot 13 and 23 which was owned by Henry and Jacqueline Nelson ("the Nelsons"); and

WHEREAS, the Loan to the Nelsons benefiting Block 7, Lots 13 and 23 is known and designated as "2003 Dam, Lake and Stream Restoration Loan, EC11-010, Lower Lake Steering Group"; and

WHEREAS, the outstanding balance due and owing on the Loan is \$111,380.32 plus interest and costs; and

WHEREAS, the Nelsons, the owner of Block 7, Lot 13 and 23, are solely obligated to pay the remaining balance of this loan plus interest and costs; and

WHEREAS, the Township was notified by the NJDEP, via letter dated June 18, 2020, that the Nelsons are now in default of their obligations under the loan; and

WHEREAS, State Law authorizes the "Township" to assess the amount of the principal, interest and costs for the loan against the real property benefitted thereby the loan of any member of the Group who may be in default or obligated for outstanding indebtedness, together with interest and penalties; and

WHEREAS, the Township adopted Ordinance 3, 2019 and Ordinance 2, 2020 which authorized a special assessment for the Amwell Dam #1 Restoration; and

WHEREAS, any and all other individuals and properties that may have been received funds or otherwise benefitted from the loan have no past or future liability or obligations of any kind or any nature.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of West Amwell in the County of Hunterdon, State of New Jersey as follows:

- 1. The Nelsons, the owner of Block 7, Lots 13 and 23, have defaulted on their repayment obligation to the State of New Jersey with respect to the 2003 Dam, Lake and Stream Restoration Loan, EC11-010, Lower Lake Steering Group.
- 2. The Township Tax Assessor is hereby authorized and directed to make and record a special assessment against Block 7, Lots 13 and 23 in the amount of \$111,380.32 plus interest and costs.
- 3. The assessment shall constitute a first and paramount lien as provided for by N.J.S.A. 40:56-33.
- 4. A copy of this Resolution shall be recorded in the Hunterdon County Clerk's Office and a copy sent to the owners of Block 7, Lots 13 and 23.
