## **CLOSED SESSION:**

**RESOLUTION #59-2009**

## POTENTIAL MENDMENT TO TOLL CONTRACT:

The Clerk reported on behalf of the Open Space chair that Toll Brothers has indicated that no formal contract amendment is needed to cover the requested work. They will proceed with the asbestos testing, etc. as outlined in the March 6<sup>th</sup> letter from Attorney Dragan.

## FARMERS MARKET ISSUE:

Chester Urbanski presented the following items prepared by Karen Baldino for the Farmers Market committee: 1) projected revenues/expenses for 2009; 2) a spending mechanism comparison; and 3) the proposed dedicated by rider resolution. Mrs. Baldino explained that a reasonable approach in determining the proposed \$2100.00 in receipts and expenditures was employed. Also, the comparison between a budget appropriation and a dedication by rider scenario for the operation of the farmers market favors the latter course of action as the funds would not have to wait on budget approval in order to be collected and spent. Mrs. Baldino stated that she spoke with the State about the proposed dedicated by rider approach be taken so as not to add the \$2100 to an already tight budget. Mr. Molnar agreed with this approach as it would keep the market as a separate entity and self-supporting.

Mr. Urbanski urged the Committee members to adopt the Dedication by Rider resolution this evening, instead of waiting for the March 18<sup>th</sup> regular meeting, in order to get a timely return from the DCA so that monies can be collected, deposited and available for

expenditure as soon as the ordinance creating the market is in place. Mrs. Baldino stated that as treasurer for the Farmers Market, she will follow approved purchasing procedures and will discuss specific concerns about payment schedules with CFO Luhrs.

#### RESOLUTION #60-2009

### RESOLUTION REQUESTING APPROVAL OF THE DIRECTOR OF THE DIVISION OF LOCAL GOVERNMENT SERVICES TO ESTABLISH A DEDICATED TRUST BY RIDER FOR RECREATION FEES PURSUANT TO PL 1999, C 292

WHEREAS, permission is required of the Director of the Division of Local Government Services for approval as a dedication by rider of revenues received by a municipality when the revenue is not subject to reasonable accurate estimates in advance; and

WHEREAS, PL 1999, C 292 allows municipalities to receive amounts for costs incurred for Recreation Fees; and

WHEREAS, N.J.S.A. 40A:4-39 provides that the Director of the Division of Local Government Services may approve expenditures of monies by dedication by rider.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Committee of the Township of West Amwell, County of Hunterdon, New Jersey as follows:

- 1. The Mayor and Committee hereby request permission of the Director of the Division of Local Government Services to pay expenditures for Recreation purposes per N.J.S.A. 40A:4-39.
- 2. The Municipal Clerk of the Township of West Amwell is hereby directed to forward two certified copies of this Resolution to the Director of the Division of Local Government Services.
