PRESENTATION OF MINUTES

Reports by Department Heads

Recycling Coordinator Ryan Rollero provided the Committee with a report which highlighted the following details:

- 1. West Amwell Township collects approximately 300 tons of solid waste per year and 150 tons of single stream recycling, but nearly 60% of the single stream collected will go directly to the landfill and never be recycled. He noted the large corporations do not care about garbage being contaminated in the recycling stream because they can increase tipping fees to process the recyclables and salvage the remaining profitable materials.
- 2. The future of West Amwell Township's municipal recycling depot will require the public to separate clean materials to be handled directly by the recyclers which will guarantee that the materials will actually be recycled and will reduce costs to the Township.
- 3. West Amwell operates the busiest municipal solid waste and recycling collection program in the County, servicing up to 350 vehicles each Saturday making traffic and pedestrian safety a top priority.

Recycling Coordinator Rollero requested the Township explore a "pay as you throw" program which essentially contracts for a curbside collection service to all residents but the tipping fees being paid by the residents through leasing a collection can from the hauler directly, or by the purchase of stickers for garbage bags. He noted this would allow the Township to shift focus towards recycling and bulk waste collection rather than weekly residential garbage. It was noted the Township's cost for garbage and recycling in 2019 is estimated to be \$70,000.

The Township Committee agreed to leave the trash permit fee at \$180 this season and not increase the rate.

Harry Heller came forward and provided an OEM update on the recent rain storm commenting that JCP&L was not accurate when they stated all residential power had been restored. Mayor Rich remarked he will keep an eye on the notifications the next time a storm hits.

Committeeman Bergenfeld stated Mr. Anderson of JCP&L has told him the highest populated areas are always taken care of first in the event of a power outage.

Mr. Heller also expressed that he would like the Township to reconsider requiring engineer's to notify neighboring property owners when a new septic system is being constructed and commented on the problems he is having with a system that was installed incorrectly next door to him. Mayor Rich asked Clerk Andrews to add this discussion to the next Board of Health agenda.

WEST AMWELL TOWNSHIP Ordinance 08, 2019

AN ORDINANCE AMENDING CHAPTER 99, ARTICLE III, SECTION 99-24 OF THE CODE OF THE TOWNSHIP OF WEST AMWELL, COUNTY OF HUNTERDON, STATE OF NEW JERSEY (Clean-up Days Fees)

WHEREAS, West Amwell Township requires residents to purchase a permit for cleanup days; and

WHEREAS, it has been determined that the current fee needs to be changed to offer Township residents additional options; and

THEREFORE, BE IT RESOLVED by the West Amwell Township Committee that Chapter 99 Article III Section 99-24 be amended as follows:

99-24. Fees.

The cost of permits per load (per trip to the depot) for cleanup days will be:

A car permit is \$50

A pickup truck permit is \$75

A trailer (non-commercial) permit is \$100

The number of permits sold for a scheduled cleanup event may be limited. Permits must be purchased prior to the cleanup day event at the Clerk's Office.

This ordinance shall become effective upon final passage and publication according to law.

TOWNSHIP OF WEST AMWELL BOND ORDINANCE 10, 2019

ORDINANCE PROVIDING FOR **ROADWAY** IMPROVEMENTS TO MILL ROAD, BY AND IN THE TOWNSHIP OF WEST AMWELL, IN THE COUNTY OF HUNTERDON, STATE OF **NEW** JERSEY; APPROPRIATING \$200,000 THEREFOR (INCLUDING A NEW JERSEY DEPARTMENT OF TRANSPORTATION **GRANT) AND AUTHORIZING THE ISSUANCE OF \$190,000** BONDS OR NOTES OF THE TOWNSHIP TO FINANCE PART OF THE COST THEREOF

BE IT ORDAINED AND ENACTED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WEST AMWELL, IN THE COUNTY OF HUNTERDON, STATE OF NEW

JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

SECTION 1. The improvement or purpose described in Section 3 of this bond ordinance is hereby authorized as a general improvement or purpose to be undertaken by the Township of West Amwell, in the County of Hunterdon, State of New Jersey (the "Township"). For the said improvement or purpose stated in Section 3, there is hereby appropriated the sum of \$200,000, which is inclusive of a grant expected to be received from the New Jersey Department of Transportation in the amount of \$150,000 (the "Grant"), and \$10,000 as the amount of down payment for said improvement or purpose required by the Local Bond Law, N.J.S.A. 40A:2-1 et seq. (the "Local Bond Law"). Said down payment is now available therefor by virtue of a provision or provisions in a previously adopted budget or budgets of the Township for down payment or for capital improvement purposes or from moneys actually held by the Township.

SECTION 2. For the financing of said improvement or purpose described in Section 3 hereof and to meet the part of said \$200,000 appropriation not provided for by application of said down payment, and until the Grant has been received, negotiable bonds of the Township are hereby authorized to be issued in the principal amount of \$190,000 pursuant to the Local Bond Law. In anticipation of the issuance of said bonds and to temporarily finance said improvement or purpose, negotiable notes of the Township in a principal amount not exceeding \$190,000 are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

SECTION 3. (a) The improvement hereby authorized and purpose for the financing of which said bonds or notes are to be issued is roadway improvements to Mill Road, which improvements shall include, as applicable, excavation, milling, paving, reconstruction and boxing out and resurfacing or full depth pavement replacement, and where necessary, the sealing of pavement cracks, the repairing and/or installation of associated curbs, sidewalks and driveway aprons, resetting utility castings, drainage work, and aesthetic improvements, and also including all engineering and design work,

surveying, construction planning, preparation of plans and specifications, permits, bid documents, construction inspection and contract administration, and all work, materials, equipment, labor and appurtenances necessary therefor or incidental thereto.

- (b) Until the Grant is received, the estimated maximum amount of bonds or notes to be issued for said improvement or purpose is \$190,000.
- (c) The estimated cost of said improvement or purpose is \$200,000, the excess thereof over the said estimated maximum amount of bonds or notes to be issued therefor, and until the Grant has been received, being the amount of \$10,000 is comprised of the down payment for said improvement or purpose.

SECTION 4. In the event the United States of America, the State of New Jersey, the County of Hunterdon, and/or a private entity make a contribution or grant in aid to the Township, including the Grant, for the improvement and purpose authorized hereby and the same shall be received by the Township prior to the issuance of the bonds or notes authorized in Section 2 hereof, then the amount of such bonds or notes to be issued shall be reduced by the amount so received from the United States of America, the State of New Jersey, the County of Hunterdon and/or a private entity. In the event, however, that any amount so contributed or granted by the United States of America, the State of New Jersey, the County of Hunterdon and/or a private equity, including the Grant, shall be received by the Township after the issuance of the bonds or notes authorized in Section 2 hereof, then such funds shall be applied to the payment of the bonds or notes so issued and shall be used for no other purpose. This Section 4 shall not apply, however, with respect to any contribution or grant in aid received by the Township as a result of using funds from this bond ordinance as "matching local funds" to receive such contribution or grant in aid.

SECTION 5. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the Chief Financial Officer of the Township, provided that no note shall mature later than one (1) year from its date or otherwise authorized by the Local Bond Law. The notes shall bear interest at such rate or rates and be in such form as

may be determined by the Chief Financial Officer. The Chief Financial Officer shall determine all matters in connection with the notes issued pursuant to this bond ordinance, and the signature of the Chief Financial Officer upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time in accordance with the provisions of the Local Bond Law. The Chief Financial Officer is hereby authorized to sell part or all of the notes from time to time at public or private sale and to deliver them to the purchaser thereof upon receipt of payment of the purchase price and accrued interest thereon from their dates to the date of delivery thereof. The Chief Financial Officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the notes pursuant to this bond ordinance is made. Such report must include the principal amount, the description, the interest rate, and the maturity schedule of the notes so sold, the price obtained and the name of the purchaser.

SECTION 6. The Capital Budget of the Township is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency, a resolution in the form promulgated by the Local Finance Board showing full detail of the amended Capital Budget and capital programs as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs will be on file in the office of the Clerk and will be available for public inspection.

SECTION 7. The following additional matters are hereby determined, declared, recited and stated:

- (a) The improvement or purpose described in Section 3 of this bond ordinance is not a current expense and is an improvement which the Township may lawfully undertake as a general improvement, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby.
- (b) The average period of usefulness of said improvement or purpose within the limitations of the Local Bond Law, according to the reasonable life thereof

computed from the date of the said bonds authorized by this bond ordinance, is 15 years.

- (c) The Supplemental Debt Statement required by the Local Bond Law has been duly made and filed in the Office of the Clerk of the Township and a complete executed duplicate thereof has been filed in the Office of the Director of the Division of Local Government Services, New Jersey Department of Community Affairs, and such statement shows that the gross debt of the Township as defined in the Local Bond Law is increased by the authorization of the bonds or notes provided for in this bond ordinance by \$190,000 and the said bonds or notes authorized by this bond ordinance will be within all debt limitations prescribed by said Local Bond Law.
- (d) An aggregate amount not exceeding \$50,000 for items of expense listed in and permitted under section 20 of the Local Bond Law is included in the estimated cost indicated herein for the purpose or improvement hereinbefore described.

SECTION 8. The full faith and credit of the Township are hereby pledged to the punctual payment of the principal of and the interest on the bonds or notes authorized by this bond ordinance. The bonds or notes shall be direct, unlimited obligations of the Township, and the Township shall be obligated to levy *ad valorem* taxes upon all the taxable real property within the Township for the payment of the bonds or notes and the interest thereon without limitation as to rate or amount.

SECTION 9. The Township hereby declares the intent of the Township to issue the bonds or bond anticipation notes in the amount authorized in Section 2 of this bond ordinance and to use proceeds to pay or reimburse expenditures for the costs of the purposes described in Section 3 of this bond ordinance. This Section 9 is a declaration of intent within the meaning and for purposes of Treasury Regulations §1.150-2 or any successor provisions of federal income tax law.

SECTION 10. The Township Chief Financial Officer is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of obligations of the Township and to execute such disclosure document on behalf of the Township. The Township Chief Financial

Officer is further authorized to enter into the appropriate undertaking to provide secondary

market disclosure on behalf of the Township pursuant to Rule 15c2-12 of the Securities

and Exchange Commission (the "Rule") for the benefit of holders and beneficial owners of

obligations of the Township and to amend such undertaking from time to time in

connection with any change in law, or interpretation thereof, provided such undertaking is

and continues to be, in the opinion of a nationally recognized bond counsel, consistent

with the requirements of the Rule. In the event that the Township fails to comply with its

undertaking, the Township shall not be liable for any monetary damages, and the remedy

shall be limited to specific performance of the undertaking.

SECTION 11. The Township covenants to maintain the exclusion from gross

income under section 103(a) of the Code of the interest on all bonds and notes issued

under this ordinance.

SECTION 12. This bond ordinance shall take effect twenty (20) days after the

first publication thereof after final adoption, as provided by the Local Bond Law.

Attorney Campbell noted the RFP will be advertised in the 5/30/19 and 6/6/19 editions of the Hunterdon County Democrat.

Mr. Shute expressed that Arecon had submitted a proposal to do the Phase II Environmental Study on Block 8 Lot 51 because they had done the original study a few months ago. He explained the quote for the Phase II is over \$6000 and asked if the Township needed to get 3 quotes for this study. Attorney Campbell advised that 3 quotes would be needed. It was noted for the record that Resolution #72-2019 will be carried to the Committee's 6/19/19 agenda.
