November 21, 2018 - 7:30 p.m.

CALL TO ORDER AND STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC **MEETINGS ACT**

The regularly scheduled meeting of the West Amwell Township Committee was called to order at 7:30 PM. Present were Mayor Stephen Bergenfeld, Deputy Mayor Gary Hoyer, Committeemen James Cally, John Dale and Zachary Rich, Acting Clerk Maria Andrews and Attorney Philip J. Faherty III.

Acting Clerk Andrews announced that this meeting is called pursuant to the provisions of the Open Public Meetings Act. Notice of this meeting was faxed to the Hunterdon County Democrat and Trenton Times on January 5, 2018, was posted on the bulletin board in the Municipal Building on said date and has remained continuously posted as required under the Statute. Mayor Bergenfeld led those in attendance in the pledge to the nation's flag.

PRESENTATION OF MINUTES

A motion by Dale, seconded by Cally to approve the Township Committee's 11/7/18 Regular Session minutes with no revisions noted was unanimously approved by voice vote.

A motion by Cally, seconded by Hoyer to approve the Township Committee's 11/7/18 Closed Session minutes with no revisions noted was unanimously approved by voice vote.

OPEN TO THE PUBLIC/TOPICS NOT ON THE AGENDA

Mayor Bergenfeld opened the floor to public comment. John Cronce came forward as a member of the Open Space Committee to discuss the Township's recognized hunting properties and asked that club members be allowed to take their ATV's on the properties to retrieve harvested deer. He noted they will follow the specific property lines and be respectful of the hay fields. Mayor Bergenfeld expressed insurance concerns as well as potential ruts and land disturbance if ATV's are utilized in wet weather. Mr. Cronce suggested insurance requirements and speed limits can be added to the hunt club rules and reviewed annually. It was noted for the record that the Committee expressed support for hunters being able to use ATV's to retrieve deer rather than dragging the harvested animals out.

Seeing no other members of the public come forward, a motion was made by Cally and seconded by Dale to close the floor to public comment. The motion was approved by voice vote.

STANDING COMMITTEE REPORTS

Open Space – Mr. Cronce wished everyone a Happy Thanksgiving and expressed appreciation for the Township Committee's support on the Runkle preservation. He noted Mr. Shute, with his historic knowledge, was instrumental in facilitating the agreement. Environmental - No report was given.

UNFINISHED BUSINESS

Re-location of Police HQ to Municipal Building Basement

Mayor Bergenfeld commented that the Fire Subcode Official has indicated the architect classified the uses of the building incorrectly and the fire proof paint may not be needed. He stated once this is confirmed the paint will be shipped back.

Rock Road West Traffic Study

Acting Clerk Andrews commented Engineer Burr is still working on his report but is aware the Committee expects to have it for their 12/5/18 meeting.

Police Lieutenant Position – Status Update

Mr. Rich noted the Chief's Association has indicated February 26, 2019 is available for the oral exam to be conducted with the 2 eligible candidates. Mr. Cally asked if all of the study materials have been received. Attorney Faherty remarked AOIC Skillman had indicated he ordered what was needed.

NEW BUSINESS/OTHER

Discussion: Mortgage Subordination – Block 21 Lot 36

Attorney Faherty explained the property owner is in the process of getting a release to the first mortgage which was tied to a recent minor subdivision and newly installed septic system. He noted the request to subordinate the mortgage will result in the Township staying in its current "second place."

Discussion: Approval of SHREC Lease Agreements

Attorney Faherty explained the company originally involved in the solar lease agreement has sold to Onyx Enterprises, LLC and they are requesting the Township sign off on the "Fourth Amendment to the facility Site Lease Agreement" naming Janus Solar Fund L.P. c/o Onyx Asset Services Group, LLC the Lessee. Mr. Cally asked if the SHREC rates can be negotiated and suggested a representative from the company come to the next Township Committee meeting to discuss the issue. Attorney Faherty stated he would reach out to Onyx and invite them to attend the 12/5/18 meeting.
