# SPECIAL WEST AMWELL TOWNSHIP COMMITTEE MEETING October 28, 2009 – 4:30 p.m.

The West Amwell Township Committee met on the above date at 4:33 p.m. Present: Mayor Corboy, Committeemen Masterson and Molnar, Attorney Howard Cohen

#### **CLOSED SESSION:**

#### **RESOLUTION #172-2009**

WHEREAS, Section 8 of the Open Public Meetings Act, Chapter 231, P.L. 1975, permits the exclusion of the public from a meeting in certain circumstances, and WHEREAS, this public body is of the opinion that such circumstances presently exist, NOW, THEREFORE, BE IT RESOLVED by the Committee of West Amwell Township, County of Hunterdon, State of New Jersey, as follows:

## PROFESSIONAL SERVICES CONTRACTS FOR 2010 & BUDGET ITEMS

Discussion centered on whether a so-called 'fair and open' or a 'non-fair and open' process would be implemented for upcoming professional services contracts. Information was provided at an earlier meeting and the details involved with each were overviewed. The decision was to continue with the non-fair and open process due to the limited amount of committee and staff time available to develop the required paperwork.

A special closed session meeting has been requested by Judge Barson and will be scheduled for November 4<sup>th</sup> at 6:30 p.m. Mr. Corboy relayed that the police study meeting will be held sometime after November 15<sup>th</sup>.

A recent Beacon article quoted the mayor as saying that employee work hours would be reinstated in January. The staff is interested in knowing if this should be anticipated and if salaries would be restored at that time. No decision made.

A preliminary budget discussion was anticipated but the Clerk was advised by the CFO that this is a bit early. However, a plan for both the Perrine property and the Hancock property needs to be developed and should be given some thought. A brief discussion ensued about the possibilities for the former (new well, RO, or COAH housing) and funding of preliminary work for the latter (demolition/cleanup plus appraisal/purchase of an adjoining parcel). Barbara Walsh, the new housing MHL/AA, has been requested to assist with this determination. Propane is on order for the former Perrine property to avoid water line freezing with cold weather coming on. Water testing will resume on the property in December after almost a year's hiatus due inability to access. The DPW

yard remediation is another unfinished piece of the area's salt contamination that will have to be dealt with at some point.
