She also noted the Fire Department Auxiliary would like to do a commemorative project in honor of all deceased members. STANDING COMMITTEE REPORTS

Open Space – Mr. Shute reported that the Runkle preservation project should be closing soon. He also noted that the CADB had recently hired Bob Hornby as their Administrator and commented he is a real, "go getter" and has created a flow chart for the process of preserving farms under the PIG program that consists of 128 steps.

Mr. Shute asked the Committee for guidance on how the Township wishes to move forward with the preservation program. Mayor Bergenfeld remarked that he believes the Township should be receptive to any landowner who expresses an interest in the program but doesn't think the Township should be knocking on anyone's door. Mr. Shute agreed and added that recent land appraisals have been coming in very low which may be discouraging to property owners.

Environmental – Mayor Bergenfeld acknowledged the letter received from the Environmental Commission regarding the recent mowing of the wildflowers around the bio-retention swale on the Township property. It was noted that the consensus of the Committee was to not change the language in the existing farming contracts per the suggestion made by the Environmental Commission, but rather to reach out to Mr. Fulper regarding the matter. Mr. Beaumont spoke up from the public and explained the wildflowers must mature. He stated the mowing was done too soon which could negatively impact the seeding of the wildflowers and their ability to sustain themselves.

It was noted that Mayor Bergenfeld said he will contact Mr. Fulper.

Mayor Bergenfeld acknowledged Janice Zuzov's resignation from the Environmental

Commission and appointed Mike Spille to the unexpired 3 year term ending 12/31/18.

A motion was made by Cally and seconded by Hoyer to post the Environmental Commission's 4/12/18 minutes to the township website. The motion was unanimously approved by roll call vote.

Township Attorney Philip Faherty reported that he has spoken with the person at the Chief's Association who coordinates the required exams and noted he will be sending information along so he can get the Township's candidates scheduled accordingly.

Rock Road West Traffic Study – Status

Mr. Rich noted he received an email from Township Engineer Bill Burr who indicated he will have a report to the Committee by 10/3/18 regarding the traffic study.

Mr. Abitz spoke up from the public and asked if the Committee could authorize permanent digital speed signs on Rock Road West. Mr. Rich stated he would speak with AOIC Skillman regarding traffic enforcement on Rock Road and also commented that he would ask about borrowing Delaware Township's digital speed sign.

NEW BUSINESS/OTHER Resolution #100-2018: Promotion of C. Gabel to Road Class C

RESOLUTION #100-2018

WHEREAS, the Township's DPW wishes to promote Christian Gabel from a Temporary Laborer to a Road Class C personnel member to perform various public works and road projects as well as general maintenance, mowing and snow removal duties; and,

WHEREAS, Christian Gabel has obtained his CDL License in accordance with his hiring agreement; and

Resolution #101-2018: "Knock Out Opioid Abuse Day – 10/6/18"

RESOLUTION #101-2018 Knock Out Opioid Abuse Day October 6, 2018

WHEREAS, New Jersey is in the midst of a life-threatening opioid abuse epidemic; and

WHEREAS, the Partnership for a Drug-Free New Jersey has designated October 6, 2018 as Knock Out Opioid Abuse Day – an initiative with a dual purpose: to educate families of the addictive qualities of opioid pain medicines and their link to heroin abuse rates in New Jersey, and communicate to physicians information on safer prescribing messages found in the Centers for Disease Control and Prevention guidelines for prescribing opioids, which include considering other therapies, setting realistic treatment goals with patients and discussing with patients the positives and negatives of opioids; and

WHEREAS, the State Senate and General Assembly jointly resolved that October 6 shall be permanently designated as Knock Out Opioid Abuse Day in New Jersey in order to raise awareness about the dangers of, and the link between, opioid abuse and heroin addiction and to educate health care providers, community leaders, state lawmakers and members of the public about the opioid abuse epidemic and its effects throughout the State of New Jersey and across the country; and

WHEREAS, West Amwell Township supports initiatives designed to raise awareness about opioid abuse in New Jersey and take steps to prevent addiction;

THEREFORE BE IT RESOLVED, that October 6, 2018 be recognized as Knock Out Opioid Abuse Day in West Amwell Township, New Jersey.

A motion by Cally, seconded by Bergenfeld to approve Resolution #101-2018 was unanimously approved by roll call vote.

Discussion: Shared Police Services Agreement

The Committee authorized Acting Clerk Andrews to forward the proposed 2019 – 2021 Police Shared Services Contract over to East Amwell Township.

Discussion: Shared Construction Department Services Agreement

Mayor Bergenfeld commented that the Construction Department numbers are down due in large part to the DCA changing the required permit fees. Ms. Brewi also noted that there were several projects done this year which were exempt from fees such as the East Amwell Township School and Clawson House. Mayor Bergenfeld suggested considering a flat administration fee in the contract. The Committee supported the idea and it was suggested an annual fee of \$5000.00 be added to the 2019-2023 Construction Shared Services Contract. Acting Clerk Andrews was authorized to forward the contract to East Amwell Township once the suggested revisions were made.

Discussion: COAH Accessory Unit Stipend: 10 or 30 Year Deed Restriction

Mayor Bergenfeld suggested the stipend for creating a COAH accessory unit be \$20,000 and that the deed restriction be for 30 years. He commented that this is in line with what has been done in the past.

Mr. Osgood spoke up from the public and asked why the Committee isn't considering a 10 year deed restriction. Mayor Bergenfeld noted again that 30 years is consistent with what has been done in the Township in the past and noted that during recent negotiations, Fair Share Housing is currently trying to push 50 year deed restrictions.

OPEN TO THE PUBLIC

Mr. Beaumont came forward again and explained the school board is mulling over options on what to do with their current facilities and are considering potentially building a new school (to encompass all of the facilities) on a site in Lambertville. Mr. Beaumont asked the Committee if they wished to have someone from the school board attend an upcoming Township Committee meeting to discuss the matter.

Mr. Rich remarked that his wife is on the school board and commented that he has not heard anything about this subject. Mr. Beaumont clarified that the issue had been discussed 2 years ago and thought it may be coming up again. Mayor Bergenfeld stated it may be a good idea to have a school board member attend a Committee meeting if and when specific details become available, but not now.

Mr. Beaumont also commented on the church for sale on County Route 518. He stated it's listed as commercial but explained the building, designated as 5 acres, is actually in the SRPD Zone while the remaining 16 acres of land is listed as commercial. He asked if there was something the Township could do to provide an incentive for it to all be sold as commercial. Mayor

Bergenfeld stated the township cannot change the zoning because that would be considered "spot zoning" which is illegal.

ADMINISTRATIVE

Mr. Cally asked Ms. Brewi, who was still in attendance at the meeting, to remind Construction Official Chris Rose that the Committee is still waiting to see his protocol memo regarding the quarterly construction reports that were not sent to the state. He explained he spoke with Mr. Rose about this and has requested a procedures memo be done to address the oversight and hopefully prevent it from occurring again. He said this is the third request and wondered if anything has been drafted. Ms. Brewi stated she will remind Mr. Rose again.

Mayor Bergenfeld referred to an email he had received from East Amwell regarding revenue reports for the construction shared services. He asked Ms. Brewi if the Township is obligated to provide these. Ms. Brewi said no and clarified that her system doesn't have the capability to provide monthly revenue reports broken out in the manner requested by East Amwell, just year end reports. She indicated she will follow up with them on the matter.

CORRESPONDENCE

The Committee ordered the correspondence listed on the agenda, filed.

ADJOURNMENT

A motion by Cally, seconded by Dale to adjourn the meeting was unanimously approved.
