September 18, 2019 - 7:30 PM

CALL TO ORDER AND STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The regularly scheduled meeting of the West Amwell Township Committee was called to order at 7:30 PM by Deputy Mayor Gary Hoyer. Present were Committeemen Stephen Bergenfeld, James Cally and John Dale along with Township Clerk Maria Andrews and Attorney Katrina Campbell. It was noted for the record that Mayor Rich arrived at 7:45 PM.

Deputy Mayor Hoyer announced that this meeting is called pursuant to the provisions of the Open Public Meetings Act. Notice of this meeting was faxed to the Hunterdon County Democrat and Trenton Times on January 10, 2019, was posted on the bulletin board in the Municipal Building on said date and has remained continuously posted as required under the Statute. A copy of this notice is and has been available to the public and is on file in the office of the Township Clerk.

FLAG SALUTE

Deputy Mayor Hoyer led those in attendance in the pledge to the nation's flag.

Clerk Andrews noted the Environmental Commission had sent in their 6/13/19 minutes and requested permission to have them posted on the website. She noted the matter should be added under Standing Committee Reports.

PRESENTATION OF MINUTES

A motion by Hoyer, seconded by Dale to approve the Township Committee's 8/13/19 Special Meeting Minutes with no revisions noted was unanimously approved by voice vote.

A motion Dale, seconded by Cally to approve the Township Committee's 8/21/19 Regular and Closed Session minutes with no revisions noted was approved by voice vote with Committeemen Bergenfeld and Hoyer abstaining.

OPEN TO THE PUBLIC/TOPICS NOT ON THE AGENDA

Deputy Mayor Hoyer opened the floor to public comment.

Karen Atwood of 57 Belvidere Avenue and Melody Anderson of 100 Belvidere Avenue came forward and asked Committeeman Cally when the structure on his property located at 83 Belvidere Avenue would be demolished. Ms. Atwood expressed frustration with the process taking so long. Committeeman Cally explained he just received the demolition permit and will be contacting contractors for quotes. He apologized for the delay noting there were title issues and stated he wasn't able to do anything until he actually owned the property with a clear title.

Mr. Samms of 4 Surrey Lane came forward and expressed concern over the Police Department's recent response to an incident at a neighboring property. Mr. Samms expressed that he thought their arrival on scene and immediate unholstering of weapons was excessive. He feared for the safety of children, adults and pets that could have potentially been outside and mistakenly walked through the yard at the time the police were there and armed. Mr. Samms stated he believes a report should be issued each time an officer unholsters their weapon.

Mayor Rich remarked that he looked into the incident upon receiving Mr. Samms' letter and commented that without divulging confidential information regarding the pending investigation,

the police were responding to a call that came in as a "burglary in progress." He indicated the Police Department's Acting Officer in Charge (AOIC) was one of the officer's responding to the scene that day and has since forwarded Mr. Samms' letter to the Hunterdon County Prosecutor's Office, Bureau of Professional Standards, for review and confirmation that all State guidelines and protocols were followed.

Mayor Rich thanked Mr. Samms for bringing the matter to the Committee's attention and stated he will take his concerns under advisement.

Dave Beaumont of 205 Rock Road West came forward and thanked the Committee again for the recently installed speed limit signs on Rock Road. He also commented on the "Equalized Data Report" the State is producing on home values. He noted West Amwell looks pretty good and remarked Lambertville had more property sales higher than the assessed values. Mr. Beaumont suggested the Committee assign this research and tracking to a specific subcommittee in the event he can no longer do it. Mayor Rich commented the Financial Advisory Committee will take over at that time.

Seeing no other members of the public come forward Mayor Rich closed the floor to public comment.

<u>Public Hearing: Ordinance 11, 2019</u> – An Ordinance of the Township of West Amwell, County of Hunterdon, State of New Jersey Authorizing the Lease of Property Owned by the Township and not Required for Public Purposes and More Commonly Known as a Portion of Block 11 Lot 18

Mayor Rich read Ordinance 11, 2019 by title.

ORDINANCE 11, 2019

AN ORDINANCE OF THE TOWNSHIP OF WEST AMWELL, COUNTY OF HUNTERDON, STATE OF NEW JERSEY AUTHORIZING THE LEASE OF CERTAIN PROPERTY OWNED BY THE TOWNSHIP AND NOT REQUIRED FOR PUBLIC PURPOSES AND MORE COMMONLY KNOWN AS A PORTION OF BLOCK 11, LOT 18.

WHEREAS, the Local Lands and Buildings Law, <u>N.J.S.A.</u> 40A:12-14 authorizes the lease by municipalities of any real property, capital improvements or personal property or interests therein, not needed for public use to the highest bidder by open public sale at auction or by submission of sealed bids after the required newspaper advertisements; and

WHEREAS, the Township of West Amwell is the owner of certain real property located on Rocktown Lambertville Road, Block 11, Lot 18; and

WHEREAS, the Township Committee has determined that it is in the best interest of the Township to lease the property for a solar facility in order to generate more revenue for the municipality; and Minutes: 8/21/19

WHEREAS, the property known as a portion of Block 11, Lot 18 was offered for lease to the highest bidder by submission of sealed bids, pursuant to <u>N.J.S.A.</u> 40A:12-14.

WHEREAS, the highest responsible bidder was NEXAMP.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Committee of the Township of West Amwell, County of Hunterdon, State of New Jersey, that:

- 1. The said property shall be leased to NEXAMP subject to the following terms and conditions:
- (a) The said property shall be leased for a monthly rent of \$1000.00 during the development period prior to BPU approval, a monthly rent of \$1000.00 during the development period after BPU approval and \$400,000.00 a year during the operation of the solar array.
- (b) The lease may be extended and/or terminated as provided for in the written Lease Agreement.

- (c) The Mayor and Clerk are authorized to execute all necessary documents to effectuate the Option and/or Lease Agreement.
- (d) The Lease Agreement shall be on file with the Township Clerk.

Effective Date.

This Ordinance shall take effect upon final passage and publication as provided by law.

Mr. Spille commented this is a significant win and noted he will continue to keep the Committee updated on the matter.

Resolution in Support of the New Jersey State League of Municipalities' Petition for Rulemaking to Amend the Uniform Construction Code

WHEREAS, the State of New Jersey has adopted a Uniform Construction Code (UCC) with the purpose to provide for uniform construction standards to insure healthy, safe and sanitary construction but also less expensive construction for the citizens of the State; and

WHEREAS, the Department of Community Affairs (DCA) has been granted authority to amend or alter provisions of the UCC to insure the intent and purposes of the UCC continue to be fulfilled; and

WHEREAS, municipal construction officials act as the enforcing agency tasked with administering and enforcing all provisions of UCC for construction within municipal boundaries; and

WHEREAS, permits and inspections form the foundation for the safe building environment; and

WHEREAS, the DCA made amendments to N.J.S.A. 5:23-1.4, 2.7, 2.14 & 2.17A, commonly known referred to as the "Minor Work" and "Ordinary Maintenance" provisions of the UCC that took effect on March 5, 2018, which undermine the UCC's intent and purpose; and

WHEREAS, unless these amendments are retracted or further remedial amendments are made to the UCC, the health, safety and welfare of the citizens of the State will be jeopardized and residents could see overall construction expenses increase if work is not properly performed; and

WHEREAS, the New Jersey State League of Municipalities along with New Jersey's six professional code official associations has filed a petition for rulemaking with the DCA requesting necessary and appropriate amendments be made to ensure the intent and purpose of the UCC is reinforced and preserved; and

NOW THEREFORE BE IT RESOLVED, that West Amwell Township supports the rulemaking petition submitted by the League and the six professional code official associations and requests that the DCA work to expeditiously adopt the measures offered by the petition; and

BE IT FURTHER RESOLVED, that copies of this Resolution be forwarded to the Governor and Lieutenant Governor of New Jersey, the Commissioner of the New Jersey Department of Community Affairs, Division of Codes and Standards and the New Jersey State League of Municipalities.

Discussion: "Bikeout" Cycling Event - 10-19-19 and 10/20/19

Clerk Andrews noted an email had been received from a Mr. Brain Kirk requesting permission for approximately 100 cyclists to ride through parts of Alexauken Creek, Queen and Bowne Station Roads on October 19th and 20th. The cyclists will be in groups of approximately 20 bike riders and will be traveling through the Township roadways somewhere between 11 AM and 2 PM. The Committee took no issue with the event but asked that Clerk Andrews convey that all cyclists be respectful of the Township residents and properties while passing through.

<u>Discussion: NJDOT Notification of Proposed Aeronautical Facility License Application</u>
Clerk Andrews noted a letter had been received from NJDOT regarding an application for a helistop on the property located at 450 Route 31. She stated the Township has until 10/18/19 to provide any comments. The Committee directed Committeeman Hoyer to work with Zoning Officer Latini on getting a letter to the NJDOT's Aeronautical Bureau prior to the comment period deadline.

Discussion: ATV's on Township Property

Committeeman Bergenfeld commented that he attended a recent Open Space meeting where concerns were raised regarding the use of ATV's on the Township owned hunting parcels. He suggested anyone utilizing the recreational vehicles to pull deer out should be required to carry liability insurance and provide a vehicle identification number for their Township issued hunting permits. Attorney Campbell stated she would reach out to the Township's insurance carrier for the specific coverage details the ATV's should have and will report back to the Committee so a letter can be sent to all of the hunters using the various properties.

Prior to going into Closed Session, Mayor Rich opened to the public in case anyone wished to speak and not have to wait until after the Closed Session.

OPEN TO THE PUBLIC

Porter Little (Jr.) came forward with the construction details and related drawings for his Eagle Scout project. He reminded the Committee he had previously proposed a 12' x 12' patio to include a wooden pavilion covering the area and a 2' perimeter for plantings on 3 of the outer sides. It will be located in the back of the municipal building, to be used by staff.

The Committee expressed support for Mr. Little's ambitious project and asked what his expected timeframe is. Mr. Little commented he would like to start construction by November 2019 and have it completed by the Spring of 2020.

Dave Beaumont came forward again and asked if the Committee still wished to pursue finding a new hosting company for the Township website. Several Committee Members supported the idea and asked Mr. Beaumont to look into what options are available.

Mr. Beaumont also commented on the recent retirement announcement of Superintendent Muenker from his position at the High School and asked if there was any update on the Facility Work Group Committee meetings. Committeeman Cally noted Lambertville has strongly expressed their desire to keep their own elementary school and the school board will now have to look into the economic feasibility of doing so.

Kathy Kennedy of 228 Mt. Airy Harbourton Road came forward and stated she had sent an email to Clerk Andrews expressing her concerns regarding a low flying airplane on 9/2/19. Porter Little (Sr.) spoke up from the public explaining the pilot was checking cover crops for the Department of Agriculture. He remarked he believed he was looking at various farm parcels

including his own and stated he would forward the contact information of the Soil Conservationist for the Department of Agriculture who is heading the program.

Ms. Kennedy requested the pilots let the Township know when they will be conducting their inspections and thanked the Committee for looking into the matter.

John Dupree of Municipal Alliance introduced himself and indicated he will be contacting the Committee Members in the upcoming months.
