Attorney Palilonis inquired about the slope of the lot. Mr. Simonye said it is gently sloping. Chairman Fulper commented on the area where the proposed barn will be being level and flat. Mr. Simonye said it is level as there was a chicken coop there.

Chairman Fulper referred to Engineer Decker's letter; a survey and topographical map are needed. The topographical map can be waived at the Board's discretion.

Chairman Fulper went over Engineer Decker's letter with the applicant. He advised Mr. Simonye to contact Engineer Decker and provide a copy of the survey to Engineer Decker and the Board.

Attorney Palilonis said the notices are in order.

Chairman Fulper does not believe they will need the topographical map; the Board is comfortable waiving this requirement.

Mr. Simonye asked that his application be carried to the next regular meeting.

Chairman Fulper announced that the application will be carried to the August 28th regular meeting. No further notice is necessary.
