Comments of the Board Members

Attorney Palilonis gave an overview of the presentation he recently attended on zoning as it relates to medical marijuana facilities. He explained there are 6 dispensaries in New Jersey with the closest one located in Cranbury. He noted the State has received over 150 new applications for dispensaries. With regard to zoning these facilities are treated like a pharmacy and municipalities can only review them from a site plan perspective for lighting, parking, drainage and landscaping compliance. Attorney Palilonis commented that such uses can be conditionally permitted in certain zones if municipalities wished to do so. He also clarified that the growing operations are not considered agricultural and are not protected under the right to farm.

Chairman Fulper opened the floor to public comment. Seeing no members of the public come forward, he closed the floor to public comment.
